High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

What we are doing

Our works have now progressed to the point where we need to occupy additional land to facilitate works on the railway. This area is shown on the map below and is to the north of the current hoarding line. This area will allow us to fully build the internal haul road and Stockpile essential materials for these works
