




# **Footpath Closure - Gower Street** 31 August – 3 September 2021 www.hs2.org.uk

# **Gower Street Foootpath Reinstatement - Tuesday 31 August - Friday 3 September**

On Tuesday 31 August CSJV will be carrying out reinstatement works on the footpath at the junction of Gower Street and Euston Road for a period of 4 days. These works are to replace the current temporary surface with the original paving stones at the pedestrian crossing.

### What to expect


A full footpath closure at the junction of Gower Street and Euston Road.
