High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work will we be doing

Following the completion of the Plant Crossing in October 2021 we will be operating this crossing using a temporary traffic light system to allow construction traffic to safely cross the lane. The lights will be set to green for Lavender Hall Lane traffic, only turning to red when a site vehicle approaches to cross the lane. The lights will be operational from 8.00am to 6.00pm Monday to Friday and 08.00am to 1.00pm Saturday. When not required the traffic lights will be removed.

When these works will take place

The Plant crossing will be operational from November 2021 to October 2024 and will only be used when necessary.

There will be advanced warning signs placed on Lavender Hall Lane for the traffic lights and we will also keep you updated through www.hs2insolihull.co.uk . Please see map overleaf for location of the plant crossing.

Duration of works

- The plant crossing will be operational from November 2021 to October 2024 as required
- Our working hours will be 8.00am until 6.00pm Monday to Friday, 8.00am to 1.00pm Saturday
- Our workforce can be on site one hour before and after to set up and take down our work equipment

- Temporary traffic lights
- Minor delays to local journeys
- The traffic lights will be removed when not required




