High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. You can sign up for regular updates in your local area at [HS2.org.uk](http://HS2.org.uk).

## Update: borehole installation behind 119 to 121 Parkway

We recently notified you about installing a borehole in the carpark area behind 119 to 121 Parkway, to monitor ground water levels in this area. To help reduce the impacts of our works, we have found another way to collect this information, so we no longer need to install this borehole.

## Update: lane & footway closure on Stanhope Street for site office fit-out – 25 & 26 August

We are currently weather-proofing the main site office, using an elevated working platform to enable workers to carry out works to the top floors and roof of the building. We cannot reach a section of the building from within site, so will need to carry out these works from the street-side. We will require a temporary lane and footway closure and six parking bay suspensions on Stanhope Street, so we can position the working platform in the road and safely carry out these works. We apologise for the inconvenience.

## Works close to Coniston – September

From 6 to 22 September, we will carry out works within our worksite to seal the old, disused sewer main beside Coniston. We will use an excavator to dig a hole close to Coniston to expose the old sewer pipe and install a large steel box to support the walls of the hole. A team will then work from within this box to open and seal the old sewer. We will then remove the box and fill in the hole. Our works will not impact local utility services.

These works will not be noisier than usual but may be more noticeable as we will be close to the building. We apologise for the disruption.

## Update: trial holes for utilities connections to worksite 31 August to 17 September

We need to create electricity and sewer connections from next to 1 Park Village East down to our track-level worksite at the northern end of the Euston Approaches. Before we start these utilities connections, we will carry out trial holes to check for the location of existing utilities. These trial holes were planned for 16 August to 3 September but will now be carried out from 31 August to 17 September. The trial holes will be within the carriageway and require a lane and footway closure and parking bay suspensions on Park Village East.

## Overnight CCTV utility surveys around Euston Approaches – 8 to 11 September

From 8 to 11 September, we will carry out overnight CCTV utility surveys of the sewer system beneath Stanhope Street, Augustus Street, Park Village East and Clarkson Row. We will access the sewer via existing manholes within the footway and road, and use a camera to assess the condition of the sewer. The results of ongoing surveys are used to help design the protective measures for utilities in the area ahead of tunnelling.

We will carry out these surveys overnight from 8pm to 5am the following day, to limit the impact on local traffic. These works will not be noisy. We will require footway closures, lane narrowing and parking bay suspensions on Stanhope Street, Augustus Street, Park Village East, Clarkson Row, Albert Street and Mornington Terrace to safely access the manholes and sewer systems below.

## Update: overnight CCTV utility survey on Parkway – postponed to 6 September

We recently said we would carry out a CCTV utility survey of the sewer system beneath Parkway, to help design protective measures for utilities ahead of tunnelling in this area. This survey will now be carried out overnight on 6 and 7 September (see map on previous page).



## Sheet piling in Camden Cutting south worksite – from 13 September

We will install sheet piling in our worksite between Granby Terrace and Mornington Street bridge, from 13 September to 22 October. We need to use a combination of the vibratory and pressed sheet piling method to install these sheets. We will carry out these works during core hours only, Monday to Friday 8am to 6pm.

We will monitor these works closely to ensure we remain within the noise and vibration limits agreed with the local council.

## Road closures on Park Village East and Harrington Street for sewer connections to worksite – mid-September to late-November

We are currently installing pipework and cables in and around our site to create connections to local utility services such as power, water and sewage.

Between September and November, we will begin works to install three new sewer connections between our worksite and the sewer beneath Park Village East and Harrington Street.

We will dig a trench in the footway and road, between our worksite and the sewer using hand-tools. We will then install the new pipework and connect it to the existing sewer, before filling in the hole. It will be noisy while we break through the footway and road to dig the trench. We will have acoustic blankets in place to limit noise as much as possible. We apologise for the disruption.

### Sewer connection #1 – Park Village East south (Sep-Oct)

From 15 September to mid-October, we will install a sewer connection within the footway and carriageway on the corner of Park Village East, Granby Terrace and Stanhope Street. We will carry out this work in two phases with each phase involving different traffic management. We will ensure access to properties at all times.

- Phase 1: 15 to 29 Sep - lane and footway closure and parking bay suspensions on Park Village East and Stanhope Street.
- Phase 2: 2 to 18 Oct - road closure on the corner of Park Village East and Stanhope Street. Traffic diverted via Augustus Street and Varndell Street.

### Sewer connection #2 – Park Village East north (Oct-Nov)

Once we have completed the southern sewer connection, we will install a second sewer connection at the northern end of Park Village East.

We will close the road at the northern end of Park Village East from mid-October to late-November, while we install pipework within the footway and carriageway.

Traffic attempting to access Park Village East from Parkway will be diverted via Albany Street, Robert Street, Stanhope Street and Park Village East. There will be access to properties at all times.

We also need to install a new water connection in this area. We will provide you with further details of these works closer to the time.

We apologise for the disruption these works will cause.




## Sewer connection #3 – Harrington Street (Sep-Oct)

From 27 September to late-October, we will install a sewer connection at the northern end of Harrington Street. We will close a section of the road between our worksite and Mackworth Street, for safe working.

There will be access to properties at all times, and we will work with refuse collection services to ensure they have access to bins.
