Update: works on Park Village East and Harrington Street

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. You can sign up for regular updates in your local area at HS2inCamden.co.uk

Update: road closure on Park Village East

We recently informed you we will install three new utility connections between our worksite and the sewers beneath Park Village East and Harrington Street.

Sewer connection #1 – Park Village East south (Sep to Oct)

We are currently installing a sewer connection within the footway and carriageway on the corner of Park Village East, Granby Terrace and Stanhope Street.

We have revised our construction programme and need to extend the current road closure.

We are carrying out the work in two phases:

- Phase 1: 24 September to 24 October road closure on the corner of Park Village East and Stanhope Street with traffic diverted via Augustus Street and Varndell Street
- Phase 2: 25 to 30 October lane and footway closure and parking bay suspensions on Park Village East and Stanhope Street

Sewer connection #2 – Park Village East north (Oct to Dec)

Once we have completed the southern sewer connection, we will install a second sewer connection at the northern end of Park Village East.

We will close a lane on Parkway and close the northern end of Park Village East from 25 October to early December while we install pipework within the footway and carriageway. We will maintain access for local residents and businesses.


Sewer connection #3 – Harrington Street (Oct to Nov)

We planned to begin works on Harrington Street on 27 September, but due to delays will now carry out these works from 7 October to early November. We will close the northern end of Harrington Street between our worksite and Mackworth Street for safe working.

Update: site access installed on Park Village East north

We recently informed you, we will install a staircase from street to track-level at the northern end of Park Village East to provide a safe and direct access for workers. The staircase will be positioned within the footway and planter on Park Village East, and extend over the brick parapet wall down to the track-level worksite.

We will also install a small 24/7 security cabin and hoarding at street-level around the staircase, for safety and security. The staircase and security cabin will eventually become part of the lorry lay-by, which we currently plan to install in early 2022. We will continue to keep you updated about the lorry lay-by as plans progress.

We were due to install the site access in late September but will now carry out these works from 25 October until early November.

We will require a lane and footway closure and parking bay suspensions at the northern end of Park Village East to install the staircase and hoarding. We will also need to clear some of the shrubs from the planter, to make way for the staircase. We will coordinate these works with the previously mentioned utility works on Park Village East, to minimise the impact on residents and traffic as much as possible.
