High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

### The work we will be doing

Crackley Lane, Kenilworth will have a diversion in place between 13 September and 25 September 2021 from 8.00 am to 6.00 pm. A fully signposted diversion route will be in place during these working hours. We will reopen the road as soon as safely possible.

This temporary closure allows us to safely move material between our sites in the area and supports our earthworks activity. This work includes the construction of Kenilworth Cutting and a box structure which will allow the HS2 line to eventually go underneath the current railway. This work requires a diversion route be put in place whilst we complete this work.

### HS2 during the Coronavirus pandemic

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with Coronavirus.

The Government's current Coronavirus strategy makes clear that construction activity can continue as long as it complies with this guidance.

The health and safety of our workforce and the communities we affect is our key priority.

Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

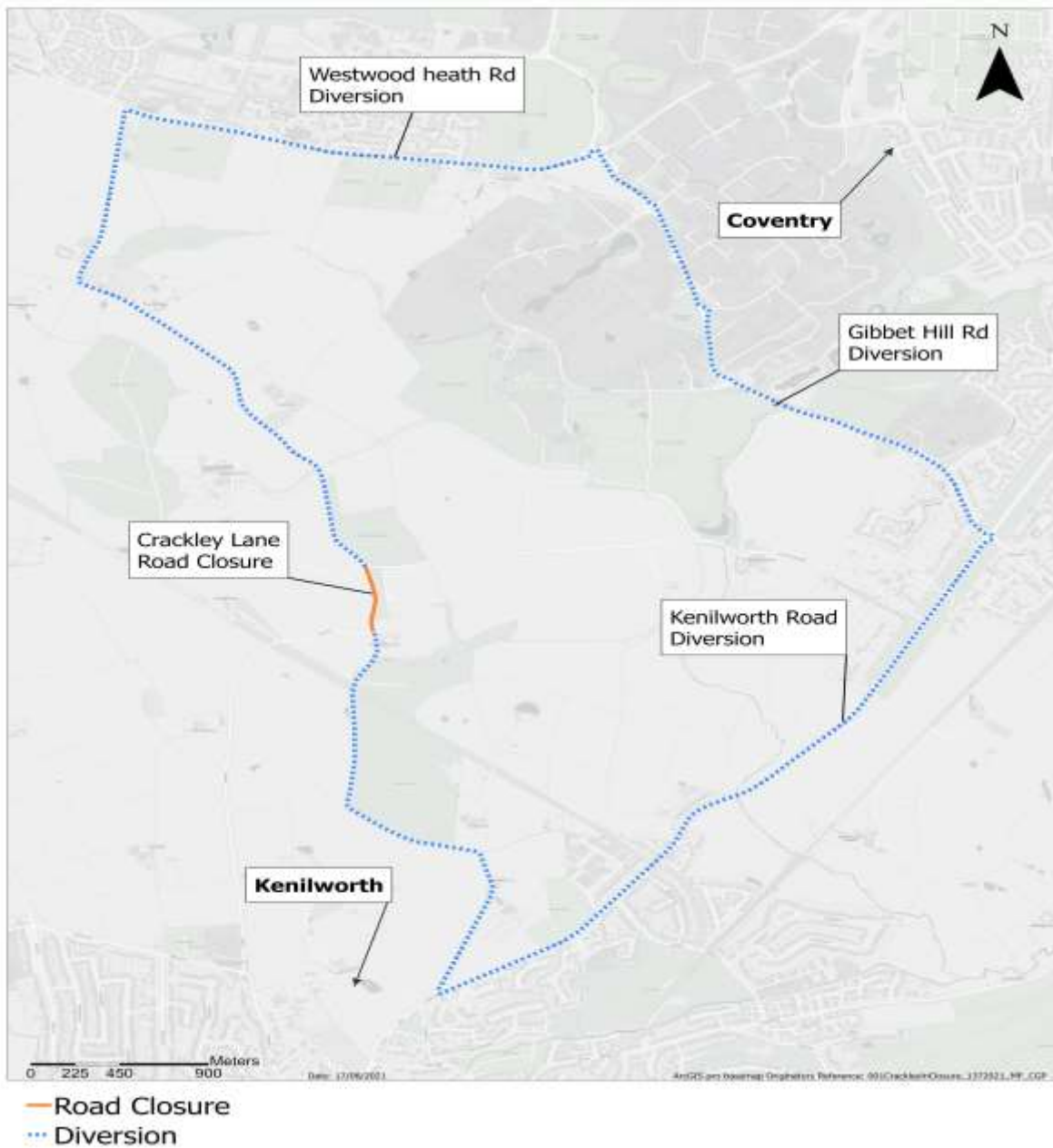
