High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty and its appointed subcontractors are working on behalf of HS2 Ltd to carry out the next phase of ground investigations work on the western leg of Phase 2b of HS2

What the works involve

Ground investigations works are being carried out to help us better understand the ground conditions along the route to inform the detailed design of the railway. The ground investigation techniques that will be used on this project will primarily include the drilling of boreholes, trial pits and cone penetration tests.

Works in your area

Investigation work is due to begin at sites along the proposed route in Manchester at:

Land to the north of Hyde Road (A57)

How will this affect you?

You may notice some people and equipment on site while we carry out the works.

Covid-19

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. Duration of works

The works are due to start on 18/08/2021 and are expected to last for approximately 4 weeks

What to expect

Working hours Monday to Friday 8am to 6pm

Any traffic management will be outside peak hours. This should only be required at the start and finish of the works

Site traffic movements will be kept to a minimum, however more cars will be present due to COVID-19 restrictions
