



Update Notice: Ground Investigation South of Wells House Road

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19.

We previously notified the community in May 2021 of ground investigation works in the area South of Wells House Road. From 31 August 2021, we will complete further ground investigation works in this area, to help us understand more about the ground conditions before we start construction of the conveyor system in this area. These works will be completed over approximately one week. A map on the next page shows the location of these works in more detail.

From the week beginning 6 September, we will also begin preparing the area for a new access route between our main station site and the site area south of Wells House Road. This will involve installing netting to the Wycombe railway bridge over Old Oak Common Lane, and you may notice additional people working in the area at this time.

We are drilling boreholes and digging pits into the ground

We will use a drilling machine to take core samples of the earth and record the ground conditions. We will also dig small pits in the ground.

You may experience a slight increase in noise during ground investigation works

The drilling machines have a small engine which will be in operation during the works and will produce some low level noise. Some intermittent noise may also be experienced when we undertake soil tests and core drilling however, this won't usually last for more than an hour at a time. We will use acoustic barriers around our work sites to help reduce the noise.

Use acoustic barriers to reduce the noise from our works

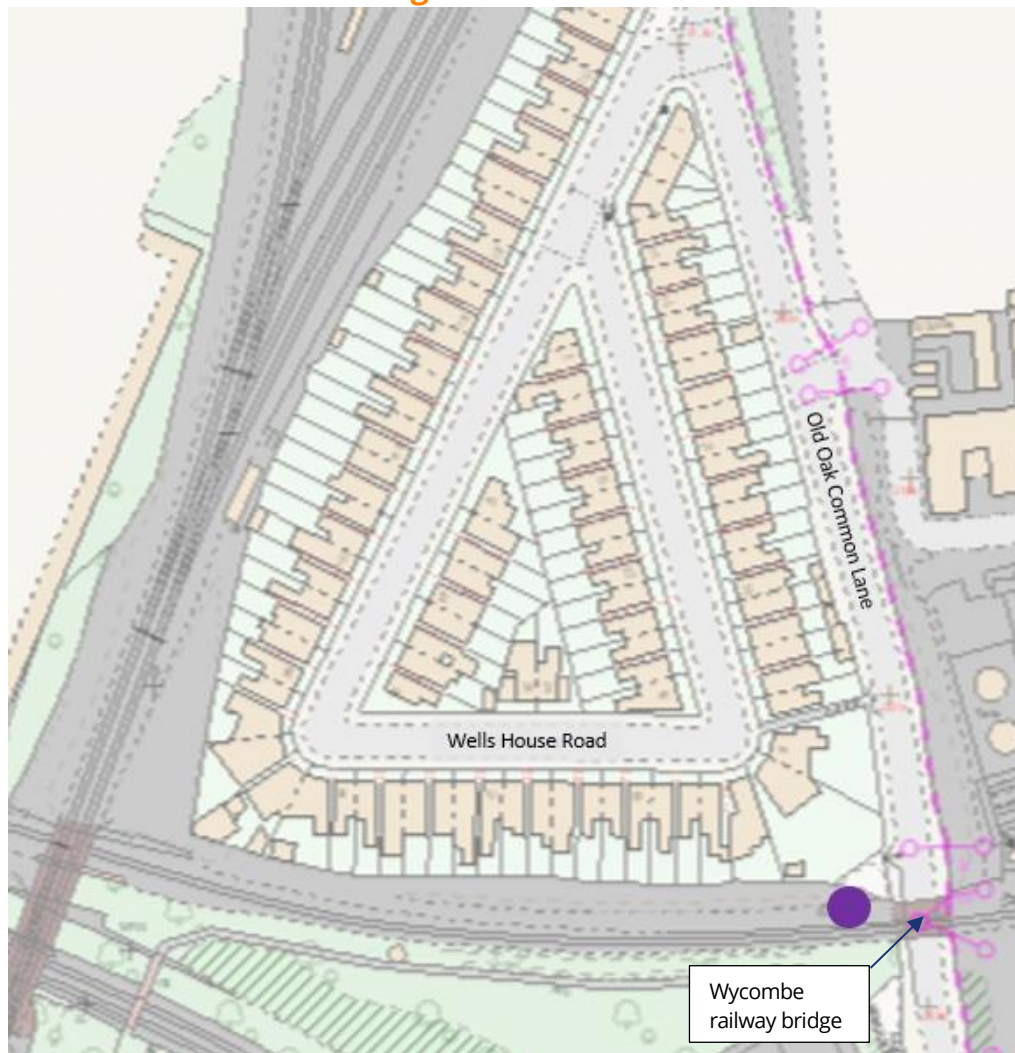
