High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

Temporary traffic lights will be in place on the A429 from 13 September to 31 October 2021.

These lights will allow us to move our plant (including large machinery), material and personnel safely over the A429 whilst we operate a crossing. This is necessary as it supports our earthworks activity in this area. This work includes the construction of Kenilworth Cutting and a box structure which will allow the HS2 line to eventually go underneath the current railway. The lights are essential and allow us to complete the work as safely as possible.

During busier periods of the day these lights will be manually operated to aid the flow of traffic and reduce disruption.

Update: From 27 September until 4 October these works will be suspended due to ground investigation works nearby. Temporary traffic lights will still be operating for the ground investigation works on the A429 in slightly different locations and will be operational between 9.30 am – 3.30 pm.

HS2 during the Coronavirus pandemic

Temporary traffic lights will be in place from 13 September to 24 September and 4 October until 31 October 2021 they will be operational between 8.00am and 6.00pm.

Our workforce may be on site one hour before and after to set up and take down our work equipment.

Some limited disruption to travel times.

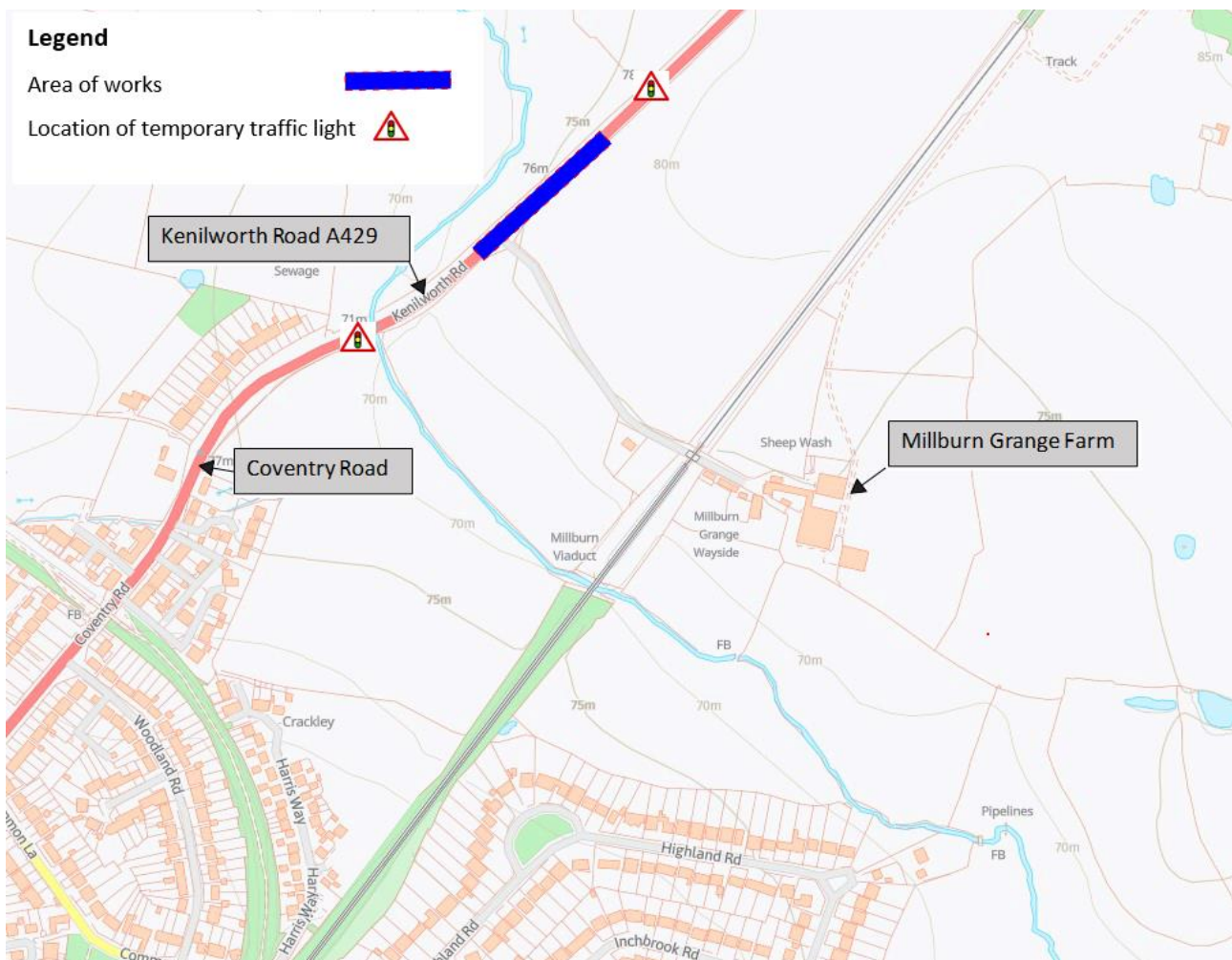
