



## Notice of underground cable works near Radstone Road

High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance.

Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. ### What are we doing?

Western Power Distribution will be remobilising to complete the remaining works on a 33kV cable diversion in the Radstone area. The work will involve removing the redundant cable and connecting the new cable to the network through a process called 'jointing'. The work will be taking place on land to the south of Radstone village, off Radstone Road.

### How will this impact you?

The works will be taking place in land south of Radstone Village. You will see vehicles and equipment in the field during the work. To access the area, we will be using an existing access point from Radstone Road. There will be some signage to show our access point, but no further traffic management is required for this work and no access is required through Radstone Village.

We will be on-site one hour either side of these times for set-up and close-down.

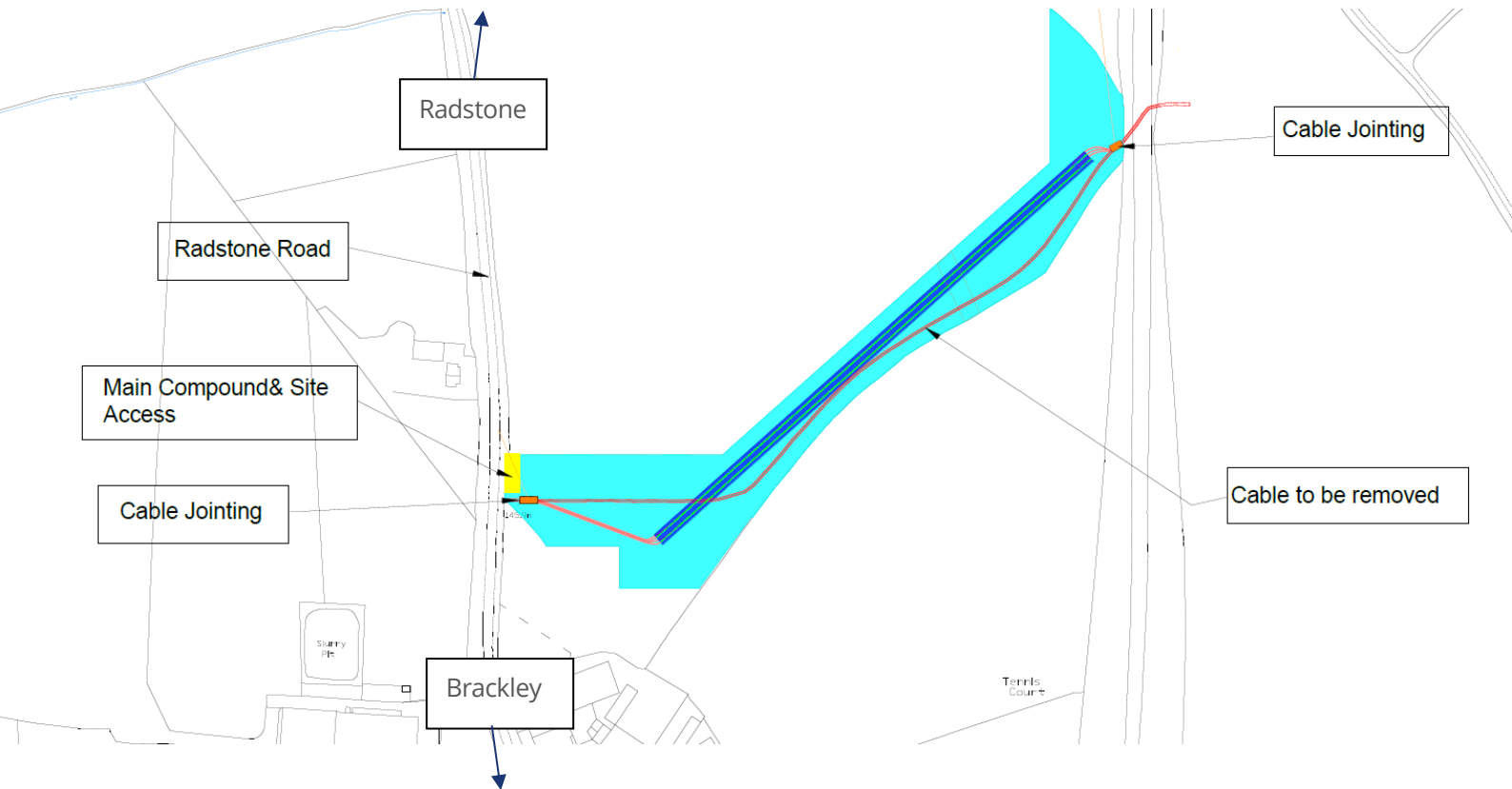
#### What we will do

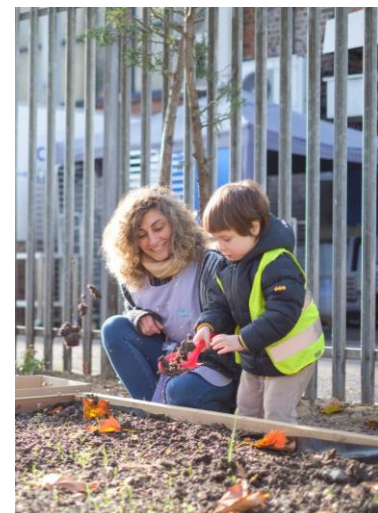
### About our Community and Business Funds
