High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. You can sign up for regular updates in your local area at **www.hs2.org.uk**.

Drainage surveys at Sunny Mews

We wrote to you previously about drainage surveys in the carpark of Sunny Mews between 13 and 17 September 2021. Due to weather conditions, we were not able to fully complete the surveys.

We will need to carry out further surveys in the carpark of Sunny Mews from 11 to 13 October between 8am and 6pm. We will access the drainage via a manhole located in the parking area of Sunny Mews and use a camera to investigate the condition of the drainage.

Our surveying team may need to flush the drainage using a high pressure water jet. There will be parking bay suspensions in place on Gloucester Avenue and a water tanker will be parked here in case we need to flush the drainage.

The dates for the surveys may change, but we will let you know if that happens.
