

Notice of access road works and crane removals at Mandeville Road site

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. You can sign up for regular updates in your local area at hs2inkilburnandnortholt.co.uk.

Site access road

From 30 September to 8 October 2021, we will be widening the access road into the main site.

These works will allow us to install and secure the hoarding at the southern end of our site, bordering the railway, to facilitate the construction of the ventilation shafts.

We will be receiving deliveries of materials on site and using a compactor to flatten the ground to make it safe.

Crane removal

On 27 and 28 September the sheet piling cranes and equipment will be removed from site. All work to prepare the cranes will be completed during core hours, 8am to 6pm, however the vehicles will have to leave site outside of these times. The lorries will leave site between 8pm and 9pm due to road restrictions in London. Traffic management will be in place for safety reasons.

How these works might affect you

You may notice periods of increased noise during these works and flashing lights may be seen during the crane removal.

We would like to apologise in advance for any disruption or inconvenience this may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way. We will ensure that disruption is kept to a minimum.

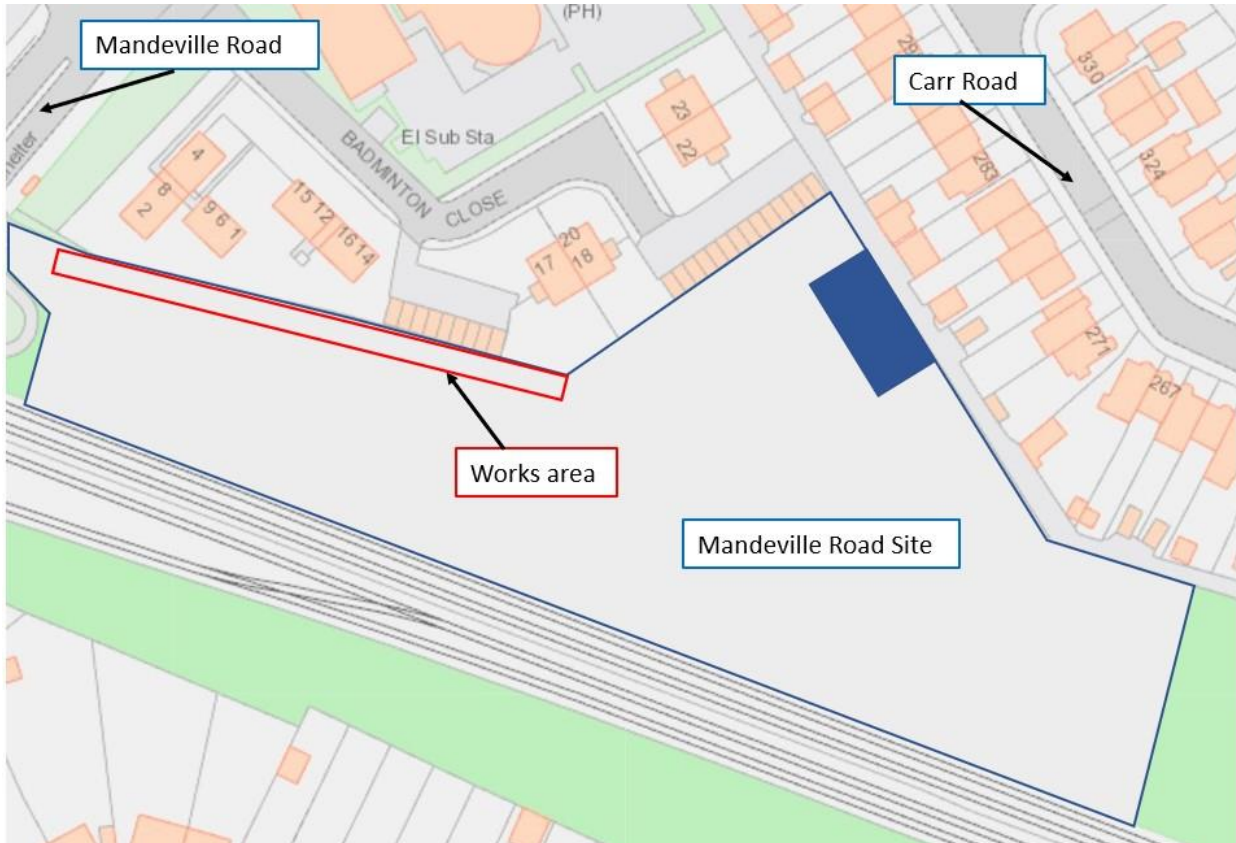
