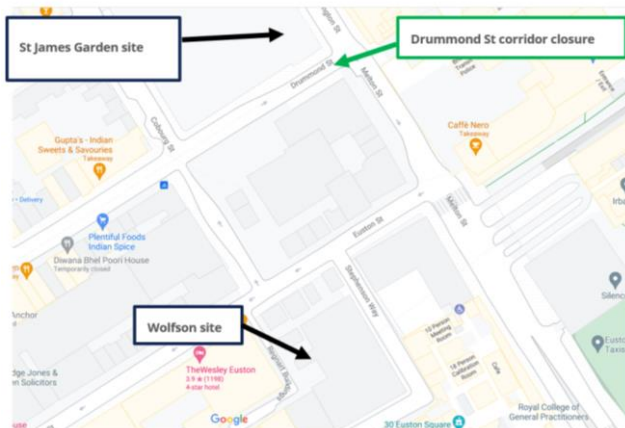


High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) guidance on COVID-19. The Government's strategy makes it clear construction can continue as long as it complies with this guidance. All sites remain under constant review. Overnight Transportation of Piling Rig

We wrote to you in April 2021 regarding ongoing works at the above location. (HS2-EW-MD-Ph1-Eu-St-S3-Site-11-20/04/2021). On **Tuesday 14 September 2021** we need to temporarily close Drummond Street (pedestrian corridor) for **1 hour between 1:30am until 7am**. This is to facilitate the delivery of a piling rig, crane and excavator from St James Garden site to the Wolfson site. At the same time, we will remove some of the hoarding panels to create room for the materials to be transported through the area. Because of the live railway these activities can only be carried out when the trains are not running.



To help people navigate through the area, we will be placing marshals on either side of the closure to help direct people and answer their questions. To remove the piling rig, we will temporary close Drummond Street corridor again. We will write to you again confirming the timing of these works.

Please note that changes to the programme may vary depending on unexpected events, cancellations etc.

Duration of works:

14 September 2021

Working hours:

- 1 hour between 1:30am to 7am

What to expect:

- Delivery of piling rig, crane and excavator between sites using low loader truck;
- We will load the rig and excavator onto the trucks before 6pm the previous day to reduce noise.

What we will do:

- Place traffic marshals on either side of the closure
