High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. What are we doing?

As part of our preparatory works and for the safety of the public, we will be closing some footpaths in the area around the west of Aylesbury and Fleet Marston.

The footpaths which are located close to or that cross the construction sites, have to be closed and diverted where possible in the interest of the safety for all users of the Public Rights of Way (PRoW)

We have committed to keeping The Greenway open at all times between Waddesdon and Aylesbury but in order to do so we may be required to undertake works in close proximity to the path. For the protection of the public we may need to narrow the path in order to carry out these works.

The footpath closures are in order to support the construction of our internal haul road alongside our bridge and viaduct structures as well as the HS2 line itself.

When will these works take place?

The works will commence from early October to the west of Aylesbury in the areas close to Hartwell and Fleet Marston.

The footpaths will have closure notices and, where possible, signposted local diversions in place around the construction works until the permanent realignments are completed in 2024.



Where will the works take place?

West Aylesbury

The majority of the works will be along the trace of the HS2 trainline. Where possible we will only close a portion of a footpath however this not always practical and, in some cases, we will need to close the entire length. The footpath closures will be signposted, and the map below shows the paths affected and the closure locations, the footpaths will remain closed until late 2024.

The footpaths to be closed in the area west of Aylesbury near Hartwell are **SBH/32/1** and **SBH/2/4.** Our team have looked at a number of ways in which diversions could be introduced however in this area, due to the programme of works and locations it has not been possible.



Notice of Public Rights of Way closures, Aylesbury



Fleet Marston

As with the west of Aylesbury, there is a footpath in the Fleet Marston area which will also be closed until late 2024. The footpath to be closed is **FMA/2** the map below shows the exact location and the extents of the closure. **FMA/1** (**The Greenway**) will remain open at all times and is the diversion route for FMA/2 as shown on the map below.

All of our construction sites will contain large plant and machinery, construction vehicles, HGV's and large articulated construction site vehicles which is why it is important to close footpaths and segregate our sites from the public.
