High Speed Two (HS2) is the new high speed railway for Britain.

North Gower Street Pedestrian Crossing Reinstatement- Saturday 11 September

On Saturday 11 September CSJV will be carrying out reinstatement works on the pedestrian crossing on North Gower Street close to the junction of Drummond Street for a period of 1 day. These works are to burn off the current worn surface and replace the crossing with new markings. A temporary road closure will be in place while these works are carried out. Drummond Street will remain open. 'Please find alternative route' signs will be in place during the works.

Stephenson Way Road Markings – Saturday 11September

On Saturday 11 September CSJV will be installing road markings along the south of Stephenson Way. These works are non intrusive and will only take a short amount of time to complete. Double yellow lines will be installed from the eastern end of Stephenson Way towards the parking bays, with single yellow lines from the parking bays towards the entrance of Stephenson Way. No traffic management is required for the duration.

North Gower Street Reinstatement – Monday 13 September to Wednesday 15 September

From Monday 13 September we will also be carrying out remedial reinstatement works on North Gower Street close to the junction with Euston Road. During these works the entrance to North Gower Street from Euston Road will be closed. The exit onto Euston Road from North Gower Street will remain open. 'Please find alternative route' signs will be in place for the duration of the works.

What to expect

A full road closure at the junction of North Gower Street Close to the junction with Drummond Street for 1 day.

A lane closure on North Gower Street heading towards Drummond Street from Monday 13 September to Wednesday 15 September. No entry to North Gower Street from Euston Road during these works


Euston Road Slip Reinstatement - Monday 13 September to Tuesday 14 September

From Monday 13 September to Tuesday 14 September, we will be carrying out road repairs to the damaged surface on Euston Road Slip near to the junction with North Gower Street. These works will be split into two phases, the first phase will be the outside lane on Monday 13 September and the second phase will be the inside lane to be carried out Tuesday 14 September. A lane closure will be in place during these works. No entry to North Gower Street from Euston Road will be possible during the works, the exit onto Euston Road from North Gower Street will remain open. Access via Hampstead Road on to Drummond Street will remain open. 'Please find alternative route' signs will be in place for the duration of the works.

North Gower Street Reinstatement – Thursday 16 September to Friday 17 September

From Thursday 16 September to Friday 17 September, we will also be carrying out remedial reinstatement works on North Gower Street close to Euston Square Hotel. These works will be conducted within safety barriers in the footpath and no traffic management will be required.
