High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. Further to the Covid-19 restrictions being relaxed we are now beginning to plan for future face-to-face engagement events and meetings. Whilst we continue to move forward, we will still continue to communicate with communities via letters, online meetings and phone calls. What we will be doing?

Following on from the earlier completed bat surveys we will now be continuing our established programme of bat mitigation. To enable this to happen safely we will need to have a full closure of Helmdon Road, daily between 27 September and 1 October 2021, during the hours of 09.30am to 3.30pm. This is to allow ecologists to safely observe and where necessary climb roadside trees to check for habitat. Subject to the outcome of these surveys tree limbs / trees may be felled at this time. The programme, location and type of traffic management required is detailed below:

Full road closure 09.30am until 3.30pm

- Helmdon Road, Greatworth – Monday 27 September until Friday 1 October 2021

The road will be open as usual outside of these hours.

Duration of works

We will be closing the following road;

Helmdon Road, Greatworth

Monday 27 September until Friday 1 October 2021

Between 9.30am and 3.30pm

Normal working hours

Monday to Friday 8am to 6pm. We may also be on site for one hour's start up and shutdown outside of these times

What to expect

Some additional traffic on local roads. Some noise from equipment used for the works

Manage any impacts, such as traffic and noise with the aim of reducing or removing them

What we will be doing? (continued)

Details of the road and diversion route can be found on the maps enclosed.

To notify road users of the upcoming road closure, verge advance warning signs will be erected.

The diversion signage will be in place and operated during the working hours described, however road closed signs will be removed when non-working hours resume. These signs will be mounted on standard A frames and secured with ballasted sandbags.

How may this affect you?

We will be working hard to ensure any impacts on residents are kept to a minimum during these and all our future works. You may notice a little extra traffic on the road immediately around the sites with workers and delivery vehicles moving to and from the site. There may be some noise from the machinery. All machinery will be restricted to running between the hours of 8am to 6pm.

For this stage of works we will not be closing any Public Rights of Way.
