## **Notice of low level** vegetation clearance

To prepare for the maintenance and power cable diversion works that are required to construct HS2's Old Oak Common Station, we will be clearing vegetation in a small parcel of land on the southwestern corner of Wells House Road (see map on page 2). The clearance works will allow further investigations of the area to be completed and the route of UK Power Network cables to be finalised.

Our ecologists have been completing inspections of the site areas in advance of the works starting, and all work will be carried out under the watching brief of an ecologist.

The low-level ground vegetation will be removed with handheld strimmers, chainsaws, a mobile chipper and other hand tools. This includes the removal of brush, ivy and small saplings. In areas where reptiles are likely to be present, vegetation will be removed in stages to allow any reptiles to move away from the work areas into suitable adjacent habitat.

Further vegetation clearances, including the removal of some trees will take place in this area early next year. You will be notified ahead of this work taking place.

It is intended that these works will be undertaken from 16 to 30 September 2021 during core working hours, on Mondays to Fridays from 8am to 6pm and on Saturdays from 8am to 1pm.

Two weeks, from 16 to 30 September 2021 on Mondays to Fridays from 8am to 6pm and on Saturdays from 8am to 1pm.

Pre-works inspections will be completed by an ecologist, and all works will be completed under the direction of an ecologist.
