High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty Vinci is working on behalf of HS2 Ltd to build the new railway in your area.

Temporary traffic lights – where, when and why

Three-way traffic lights are planned to be in operation along a section of the A425 Leamington Road, Southam, on Tuesday 5 and Wednesday 6 October 2021 during off-peak (9.30am – 3.30pm) hours. This is to allow us to carry out early preparatory works in readiness for main tunnelling works when the tunnel boring machine is turned around from our South to North portal, scheduled for the first quarter of 2022.
