High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

Upcoming utility surveys

We will be carrying out trial hole surveys and vegetation clearance in locations on the A47 Heartlands Parkway, adjacent to Aston Church Road on Monday 20 September and Tuesday 21 September.

In the same location we will also be completing overnight trial hole surveys on Wednesday 22 September and Thursday 23 September. Dates are subject to the progress of the surveys programme.

To complete the utility trial hole inspections, we will use a vacuum excavator, which uses compressed air to loosen or agitate the ground. The loosened material is then removed using the vacuum on the machine creating a hole. At times we will also use hand digging tools to excavate the trial holes. Once the surveys are carried out, we will backfill and reinstate all the trial holes.

Overnight road closure and temporary traffic lights

To be able to carry out these inspections safely and effectively, we will need to put in place a lane closure between 9.00am and 3.00pm on Monday 20 September and Tuesday 21 September. We will then put in place the same lane closure between 9.00pm and 5.00am overnight on Wednesday 22 September and Thursday 23 September. Access to properties and businesses will be maintained at all times.


