## Notice of demolition on Park Street

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are carried out by a joint venture between Laing O'Rourke and Murphy & Sons known as LM.

### We'll be carrying out demolition works on Park Street

We've got a safe plan in place to manage the demolition and materials on Park Street. When we take down a building, we remove materials and strip the building back to its base structure. Once the frame is exposed, we make final checks to confirm our demolition plan is correct, then complete the clearance.

Demolition waste is sorted and recycled to meet our target of recycling more than 90 per cent of the materials.
