



# **Notice of survey works on** A413 - Chalfont St Giles

High Speed Two (HS2) is the new high speed railway for Britain. We will be undertaking survey works on the A413 at Bottom House Farm Lane to inform the final design of the junction with the Lane and the A413.

# Where and how are the works taking place?

They will be taking place each day from 9am to 4pm Monday 11 October to Friday 15 October on the A413 at the junction with Bottom House Farm Lane.

Lane closures of the A413 using temporary traffic lights will allow staff to conduct the surveys safely.

The lights will also manage the movement of HS2 vehicles on and off the temporary access road, as well as residents and businesses vehicles from Bottom House Farm Lane.

# Why are these works taking place?

Once the construction of the vent shaft is complete and the mechanical and electrical equipment for its ongoing use have been installed, the temporary access road running parallel to Bottom House Farm Lane will be removed. Maintenance vehicles for the vent shaft will then use Bottom House Farm Lane for access.

The junction with Bottom House Farm Lane and the A413 needs to be designed and constructed to meet current highway standards which the current gradient of the lane onto the A413 does not meet.
