### Update notice of gate works at **West Midlands Fire Service HQ**

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

### **Changes to West Midlands Fire Service Head Quarters** access gate

As we build the new railway, we will need to increase the height of West Midlands Fire Service's access gate on Vauxhall Road. We need to do this work because the current gate for large vehicles on St James Place will need to be closed as we construct the new HS2 viaducts.

Construction work on the access gate will continue until the end of November 2021. Core working hours for these works will be Monday to Friday 8am - 6pm, and Saturday 8am -1pm.

#### What to expect

Whilst we carry out these works you can expect to see some deliveries being made to the site. You can also expect to see workers in hi-vis working at the site access point. We will use machinery and tools to help us complete the works, but we do not expect the works to cause high levels of noise or vibrations.

#### **HS2 during the COVID-19 pandemic**

We are continually reviewing the works on our construction sites in line with the Government and Public Health England (PHE) advice on dealing with coronavirus. The Government's current coronavirus strategy makes clear that construction activity can continue as long as it complies with guidance. The health and safety of our workforce and the communities we affect is our key priority. Please be assured that those sites that are currently still working are doing so because they can operate within PHE and construction industry guidelines.

Ensure that our work areas are safe and secure.


