High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

Changes to vegetation clearance lane closures

We no longer need to close a lane on A47 Heartlands Parkway from Monday 20 September to Tuesday 21 September as the vegetation clearance that was planned has been reduced.

We will now be able to complete the vegetation clearance in a single day with a lane closure between 9.00am and 3.00pm on Wednesday 22 September.

Trial hole survey lane closures remain the same

The overnight lane closures for the trial hole surveys remain unchanged and will still take place between 9.00pm and 5.00am on Wednesday 22 September and Thursday 23 September.

Access to properties and businesses will be maintained at all times.

Duration of works

Lane closure A47 Heartlands Parkway adjacent to Aston Church Road 22 September (one day) working hours 9.00am – 3.00pm.

Lane closure A47 Heartlands Parkway adjacent to Aston Church Road 22 and 23 September (two nights) working hours 9.00pm – 5.00am.

Our workforce can be on site up to 1 hour before work begins to set up the site and again afterwards to take down our work equipment.

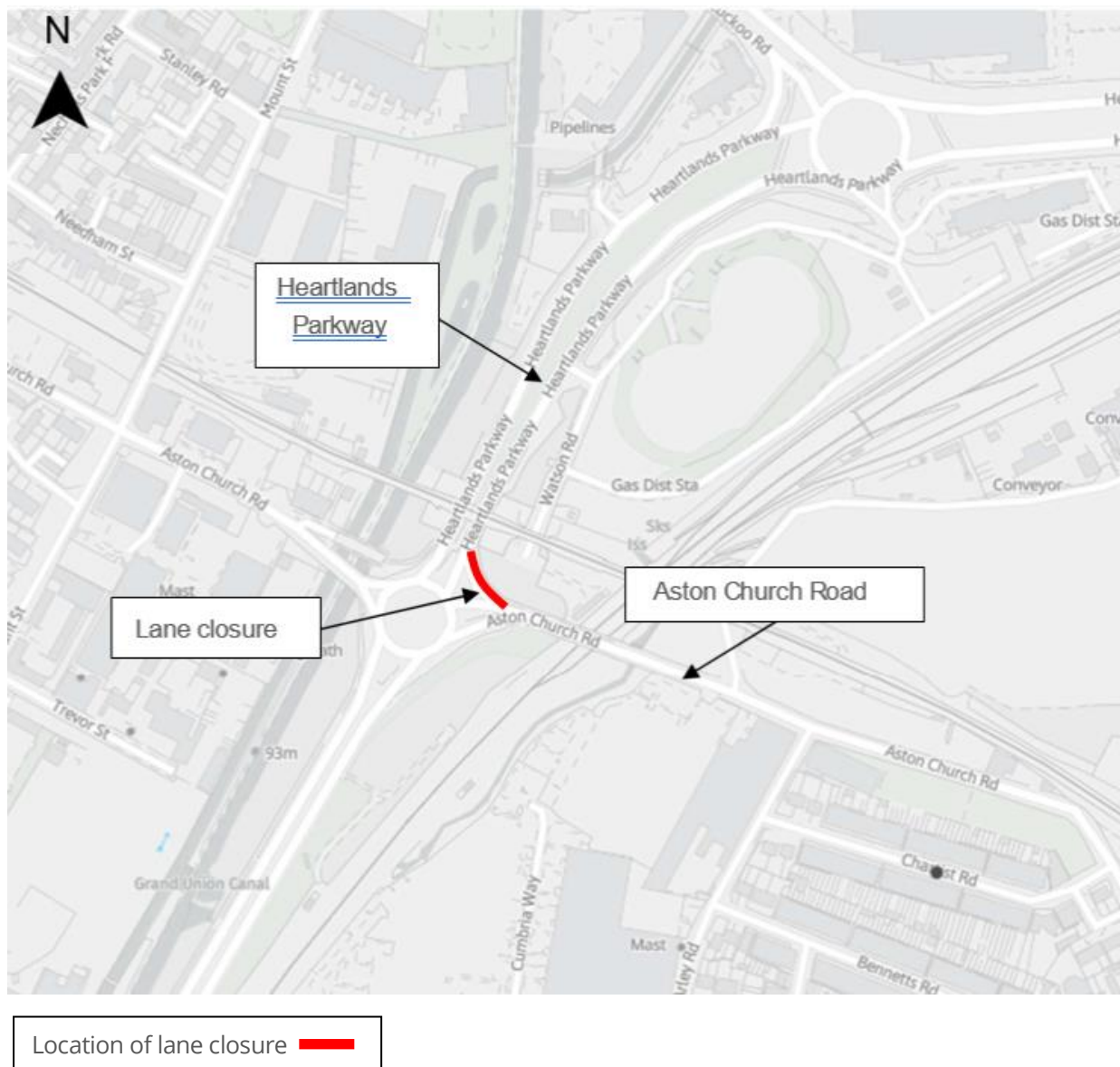
