High Speed Two (HS2) is the new high speed railway for Britain.

What we are doing

We wrote to you in August to notify you of some vegetation clearance we need to undertake starting on 6 September. These works have been rescheduled and will now take place towards the end of September. From 20 to 22 September 2021, we will be clearing vegetation from the underside of the railway bridge to the south of Rabournmead Drive, Ruislip.

How these works might affect you

You may experience short periods of low level noise from petrol operated hedge cutters and strimmers. Welfare vehicles will be parked on Rabournmead Drive.

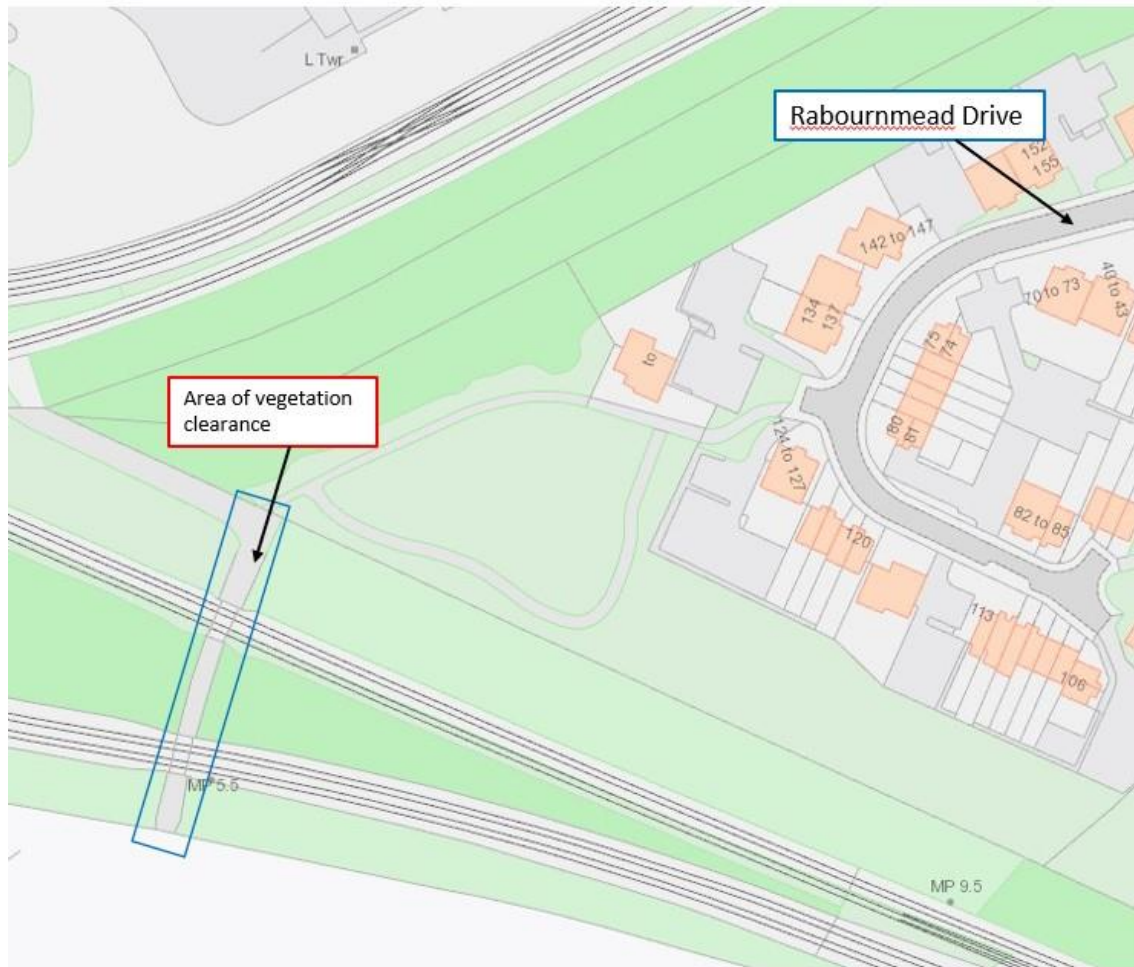
