High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. You can sign up for regular updates in your local area at hs2inhillingdon.co.uk

What we are doing

We wrote to you in August to notify you of utility works starting at the Victoria Retail Park. These dates have been rescheduled and will now take place from 20 September to 4 December 2021. We will be digging a trench in Victoria Retail Park on Victoria Road, Ruislip, in the area shown on the map overleaf. This trench will contain the utility supply into our site while building HS2.

We will be digging the trench in sections between Victoria Road and our site behind the Victoria Retail Park. We will start near our site and progress towards the retail park entrance and main road.

How the work might affect you

Temporary traffic management and a lane closure will be in place to ensure the work can be carried out safely.

The Old Dairy and Victoria Retail Park will remain open during these works.
