## Rooftop surveys in November 2021

During November, our surveyors will be visiting the rooftop several times during November, but the exact dates are yet to be confirmed. The surveys will help to inform our design decisions for the future construction of the HS2 London tunnels.

We will use handheld equipment on the building rooftop to measure the distance between our sites. We will carry out the surveys during the day between 9am and 6pm. We will not need to access any other parts of the building and the surveys should not cause any disruption to you. You may notice two or three operatives on the building rooftop during the surveys.
