## What we are doing

The weekend of 23 and 24 October 2021, we will be carrying out work to remove portacabins within our site compound at West Ruislip, as shown in the picture below.

We will use a crane to lift the portacabins onto a lorry. These works should not cause any disruption.

Due to the location of the building in a constricted area, we will remove it during the weekend to ensure the activity can be carried out safely.
