Notice of drainage investigations on Hill Lane and Field Way

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19.

What we are doing

From 3 to 11 November 2021, we will be carrying out drainage investigations along Hill Lane and Field Way, in the area shown on the map overleaf.

We will be using a CCTV camera mounted on a small robot. Should we find a blockage, we may need to flush the drainage system using a high-pressure water jet in order to carry out the investigation. These surveys should not cause any disruption.

In order to carry out these surveys safely, a footpath diversion will be in place and the cycle path will be closed for the duration of these works.

Access to the Hill Lane Playground will be maintained. There will be no disruption to your utility services.

- Hill Lane 3 to 5 November
- Field Way 10 and 11 November

Footpath diversion and cycle lane closure

Operatives and surveying equipment (including a CCTV camera) will be present, as well as a water tanker should we need to clear a blockage

Maintain access to your property at all times
