Notice of earthworks, Aylesbury South Cutting

High Speed Two (HS2) is the new high speed railway for Britain. We continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. What are we doing?

In mid-October, we will be installing temporary and permanent drainage systems and commencing the bulk excavation for our Aylesbury South Cutting. This work will involve the excavation, movement, storage and reuse of earthworks.

We will be removing topsoil as well as sub-soil and moving it from one area to another, along the project route, to form embankments, stockpiles and subbase for the main line. Some of the excavated material will also be used to support construction of the footpath overbridges and Stoke Mandeville bypass structures.

EKFB will deploy full time tractors and bowsters to spray the whole route, to suppress any dust generation that may arise from the articulated dump trucks hauling the soil. All stockpiles will be sprayed and compacted to avoid having loose topsoil. Stockpiles will be seeded, irrigated and maintained to form a vegetation layer on top of long-term stockpiles.

Environmental advisors, construction supervisors and managers will undertake regular inspections to ensure that these measures are consistently in place. Works will also be closely monitored via the installation of noise monitoring equipment.

When will these works take place?

These works will commence mid-October. Works will take place between 8am and 6pm – Monday to Friday but likely to finish earlier in the winter months as the daylight fades. Some additional weekend work may also take place.
