



Updated notice of Stoneleigh Road and Stareton Lane road closures

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

Traffic management update

As you are aware, we will be creating a plant crossing on Stoneleigh Road. This crossing will allow us to safely move our construction plant across the road as we undertake various works in the area.

Due to unforeseen circumstances, we will be changing the schedule of works on Stareton Lane. There is currently a road closure in place on Stareton Lane, which is in place for 24-hours, seven days a week until **30 January 2022**. These works will be suspended over the festive season.

In addition, there will be a road closure on Stoneleigh Road, between Stoneleigh Park and Coventry Road, for 24-hours, seven days a week from **17 January to 4 February 2022**. Temporary traffic lights will be in operation on Stoneleigh Road from **4 February to 20 February 2022**. A fully signed diversion will be in place for both closures.

Access to all premises on Stareton Lane and businesses in Stoneleigh Park will be maintained during these works.

On completion of the plant crossing, the lights will remain green and will only turn to red when site vehicles are required to cross the road. To further reduce disruption, these lights will be manned during busier periods of the day. Please note that these works are subject to weather conditions.

Duration of works Stoneleigh Road and Stareton Lane

- Road closure in place on Stareton Lane until **30 January 2022** and will be on Stoneleigh Road, between Stoneleigh Park and Coventry Road, from **17 January to 4 February 2022**.
- Temporary traffic lights in operation on Stoneleigh Road from **4 February to 20 February 2022**.
- Stareton Lane and Stoneleigh Road will be closed for 24-hours, 7 days a week.

What to expect

- Some disruption to travel times.
- Some machinery noise.
- Fully signed diversion will be in place.

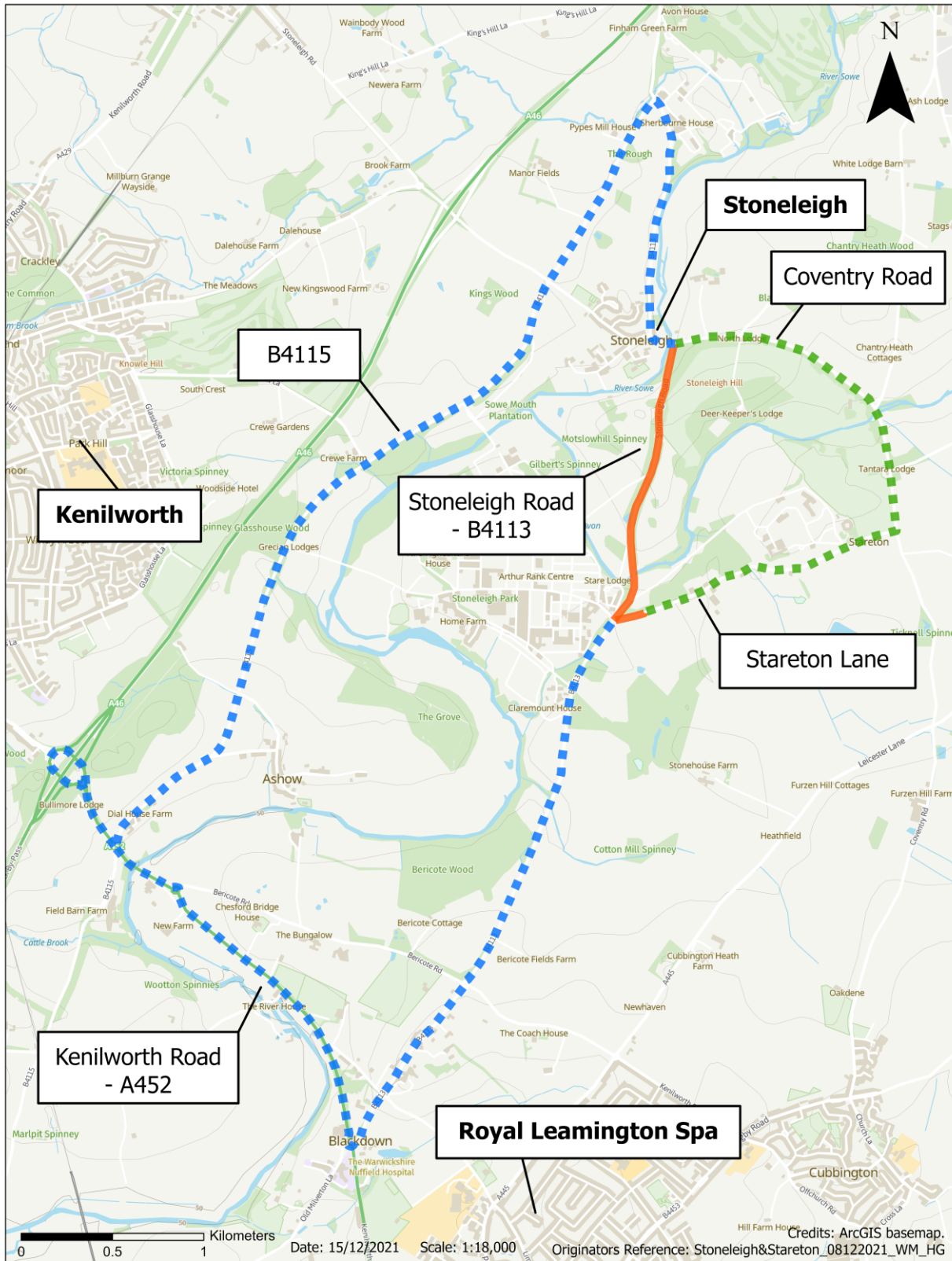

Map showing road closure on Stareton Lane and associated diversion route



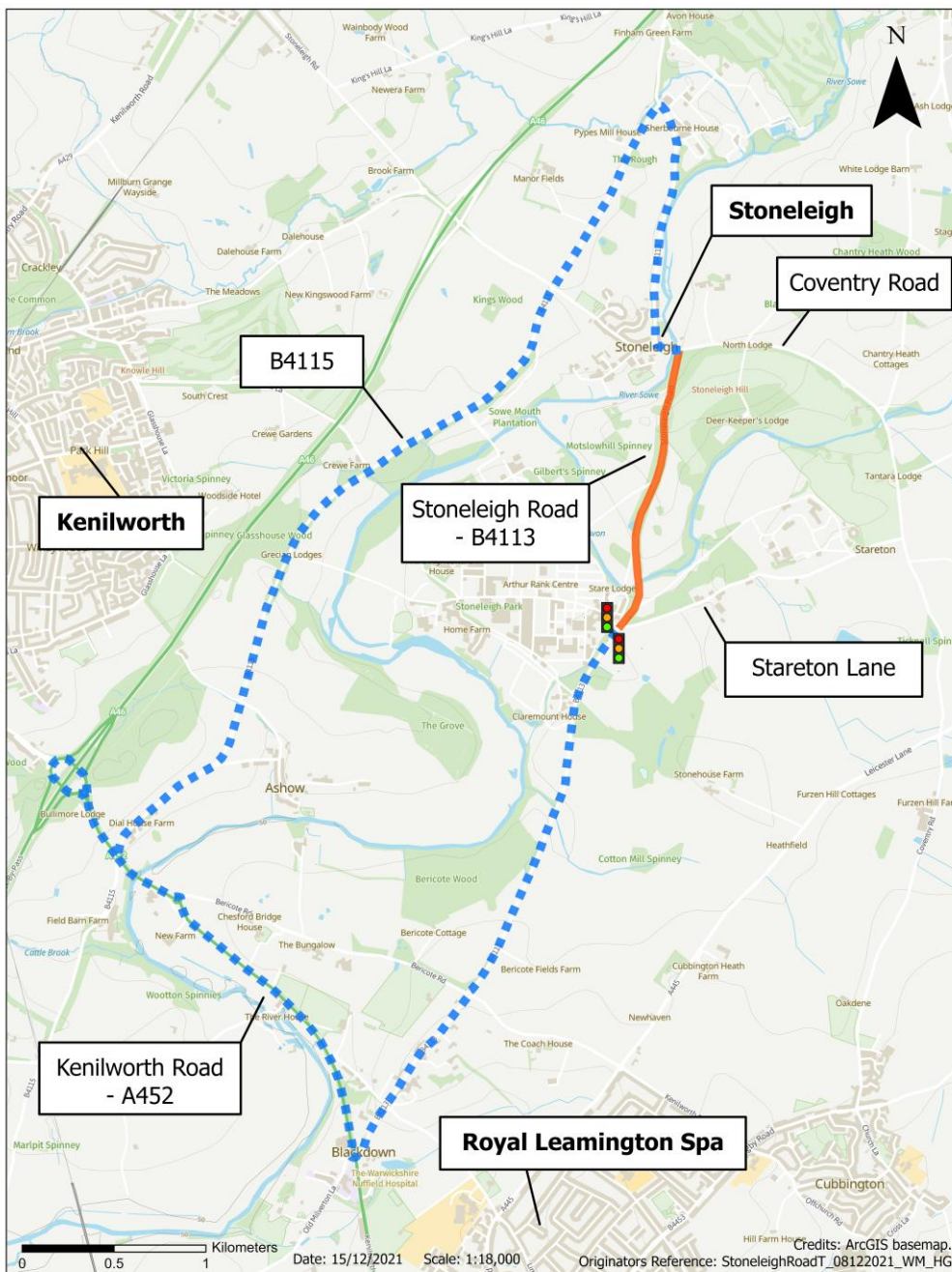
