

Notice of road closure – Baulk Lane, Berkswell

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

Due to the temporary full closure of Lavender Hall Lane until the 15 October 2021 it has become necessary to temporarily close Baulk Lane for safety reasons. This is due to the signed diversion not being followed and a number of complaints from local residents. There will be a fully signed diversion in place during the closure - please see map overleaf. Access to properties will be maintained at all times.

This closure is for motor vehicles only and will remain open for pedestrians, cyclists and horse riders.

When these works will take place

This is short notice and will be implemented on Friday 8 October to the 15 October. There will be advanced warning signs placed on Truggist Lane and Spencers Lane and we will also keep you updated through www.hs2insolihull.co.uk.

- A signed diversion.

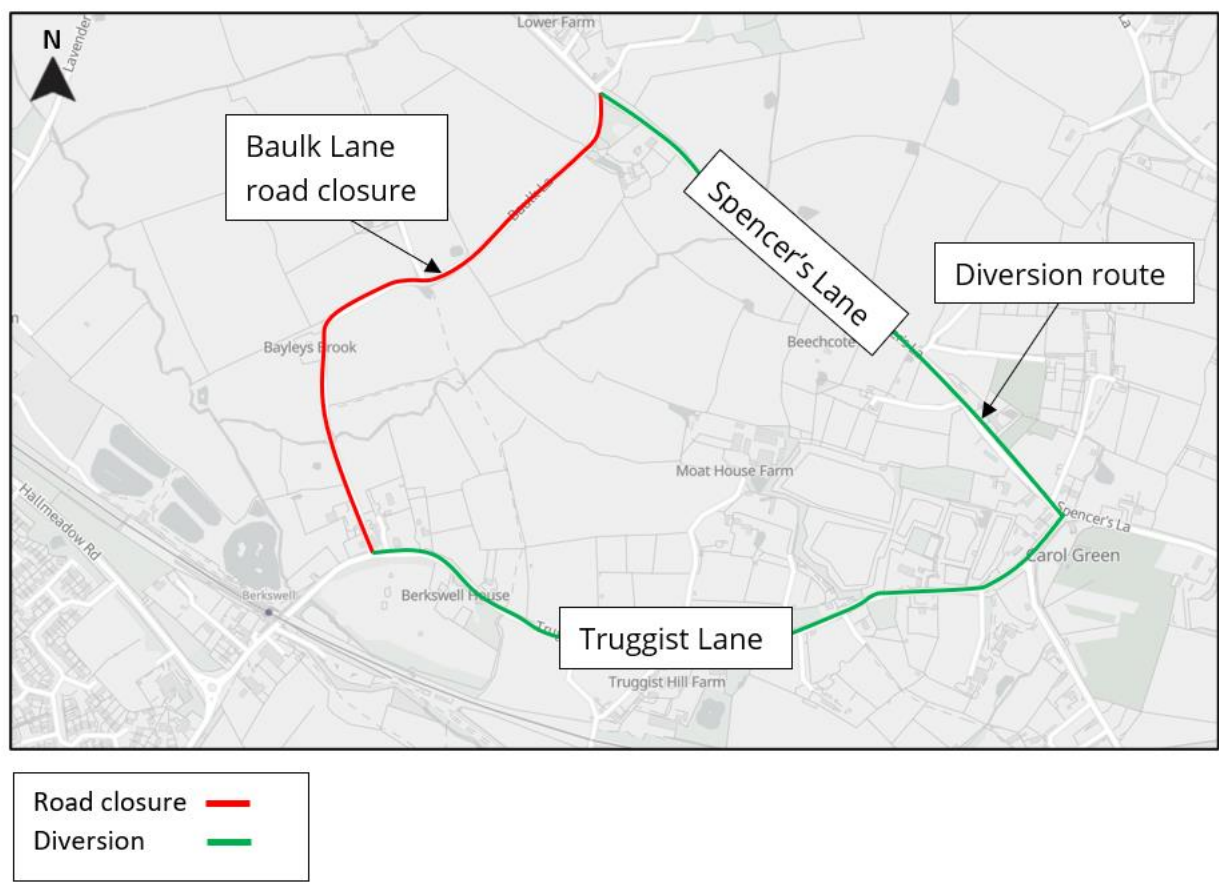
