High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

Postponed changes to road layout

Ahead of constructing the viaducts that will carry the HS2 line to the new purpose-built Curzon Street Station we will need to make some changes to the layout of Northumberland Street. We have however had to postpone the work that we had planned to start in mid-November to construct a turning point on Northumberland Street. We will let communities and stakeholders know once we have a new date.
