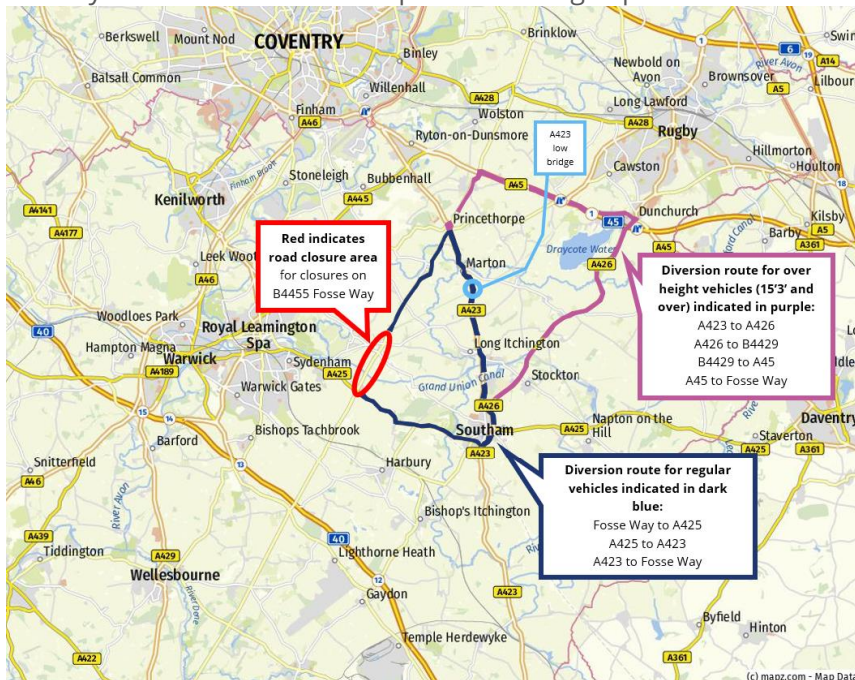
Notice of temporary closure on B4455 Fosse Way in Offchurch

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are underway in your area, carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

Following our recent notice providing an overview of work on the B4455 Fosse Way in Offchurch, Warwickshire, this is an update that from **Friday morning 12 November 2021 the Fosse Way is due to be closed 24 hours a day, 7 days a week until early December**. The road closure is needed to finish building a new roundabout at the junction of Fosse Way and Welsh Road. The roundabout will keep everyone moving safely through the area during HS2 construction and operation. **Welsh Road will also remain closed between Long Itchington Road and Bascote Road until early 2022.**

Duration of work

Fosse Way closed 12 November to early December 2021.

Welsh Road to remain closed until early 2022.

Our working hours

24 hours a day, 7 days a week during the road closure period.

Potential traffic delays during peak times.
Some noise from machinery.
24/7 working.

Maintain access to properties, and for emergency services to the properties.
