

Updated dates - Temporary road closure - Long Itchington Road

High Speed Two (HS2) is the new high speed railway for Britain. Early works for HS2 are now underway in your area, carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

Road closures on Long Itchington Road

LM is shortly due to start works for the second roundabout at The Fosse Way/Long Itchington Road junction. This means that Long Itchington Road (National Cycle Rte. 41) will need to close on both sides of the Fosse Way between 14 February until late May 2022.

The reason for the closure is to carry out utility connections, drainage, earthworks, carriageway realignment and tie-in works etc. as required for the construction of the roundabout at this location.

Also as previously notified, temporary traffic lights will continue be erected along the Fosse Way as and when required until the next phase of works commences along the Fosse Way, where a section of the Fosse Way and Long Itchington Road will be closed simultaneously around mid-April, to complete the roundabout at this location. However, we will send a notification closer to the time to confirm dates.

Access for properties and cyclists

Access will be maintained for households and businesses along the route and also for cyclists through National Cycle Route 41. A clearly signposted diversion will be in place (see map below).

If your property frontage is within the closure points, we will work with you to manage access into and out of your property. You may sometimes experience a short delay whilst we move machinery or create a safe path within the closed area during our working hours.

This timeframe is subject to consent, site and weather conditions so please do check on the road signs – any changes will be published on: www.hs2.org.uk/works-affecting-highways-in-south-warwickshire/. We apologise for any inconvenience caused.

Potential traffic delays. Some noise from machinery.


