High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. Further to the Covid-19 restrictions being relaxed we are now beginning to plan for future face-to-face engagement events and meetings. What will we be doing?

As part of our continuing works ahead of the construction of the railway we need to undertake some further works in your area.

- Full road closure
- Vegetation / tree clearance

Full road closure and vegetation / tree clearance

We are continuing our established programme of ecology and mitigation works. We have completed all survey works and now we need to undertake a series of mitigation works in accordance with the ecological seasonal calendar. However, there will be further ecological and tree surveys undertaken of the vegetation that we need to remove. Work will be conducted in compliance with all applicable HS2 and Natural England licenses for protected species, including:

- HS2 Organisational European Protected Species Great for Crested Newt Licences WML025
- Licencing applications to Natural England for bats

We will be working hard to ensure any impact on residents is kept to a minimum during these works.

Full road closure and vegetation clearance continued

To enable vegetation clearance along Wardington Road we will need to close the road between 8 and 12 November 2021 from 08.00am until 4.00pm. This is to allow ecologists to safely observe and where necessary climb roadside trees to check for habitat before felling.

To reduce the impact of road closures on local residents we are working together with EKFB, the main works contractor, who will conduct trial holes for utilities relating to future utility diversion planning within these road closures.

Full Road Closure between 08.00am until 4.00pm.

8 – 12 November 2021

The road will be open as usual outside of these hours.

Details of the road closure and diversion routes can be found on the maps enclosed.

To notify road users of the upcoming road closure, verge advance warning signs will be erected.

The diversion signage will be in place and operated during the working hours described. Road closed signs will be removed when non-working hours resume. These verge signs will be mounted on standard A frames and secured with ballasted sandbags.
