High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. Further to the Covid-19 restrictions being relaxed we are now beginning to plan for future face-to-face engagement events and meetings. Whilst we continue to move forward, we will still continue to communicate with communities via letters, online meetings and phone calls. What we will be doing?

Following on from the earlier completed ecology surveys and bat/ecology mitigation on Phase 5 of our works in your area (Banbury Road), we need to return to this section to remove some felled trees which we were unable to complete within the original closure. Please see works notice here; HS2 Works Notification: Notice of road closures, Wormleighton - High Speed 2

To enable us to complete this work safely we need to install traffic lights with a lane closure on Banbury Road

Saturday 6 November 2021 between 8am and 1pm.

This is subject to final consents and approval from the Local Authority. The road will be open as normal after this time

To reduce the impact of these works we will not close Banbury Road (Phase 7) on Saturday 6 November 2021

Manage any impacts, such as traffic and noise with the aim of reducing or removing them


