High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

What work will be taking place

In July 2021 we sent out a notification outlining works to create a piling platform to enable the construction works of the Curdworth Box. Once constructed the Curdworth Box will carry HS2 over the existing network rail line. The piling platform for this has been constructed and we will now be undertaking the piling works in our works area off Faraday Avenue. The piling will allow us to provide a support for the Curdworth Box structure to be built on top of. Throughout these works we will continue to bring deliveries through the Newlands Farm entrance.

Duration of the works

The works will begin on Tuesday 26 October 2021 and will continue until April 2022. We will be working within our core hours of 8.00am -6.00pm on weekdays and 8.00am – 1.00pm on Saturdays.


