High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

Crackley Lane, Kenilworth will be closed between 2 November and 19 November, during this time we will be carrying out work to construct a plant crossing. This will involve a section of the old road being replaced with a reinforced concrete slab to take the weight of heavy machinery crossing the lane. Access to all properties will be maintained at all times.

To carry out this work safely the road will be fully closed during this period for motor vehicles, but pedestrian access will be maintained throughout the closure. There will be a fully signed diversion in place - please see map overleaf.

Low levels of noise from the work we are completing and delays to local journeys.

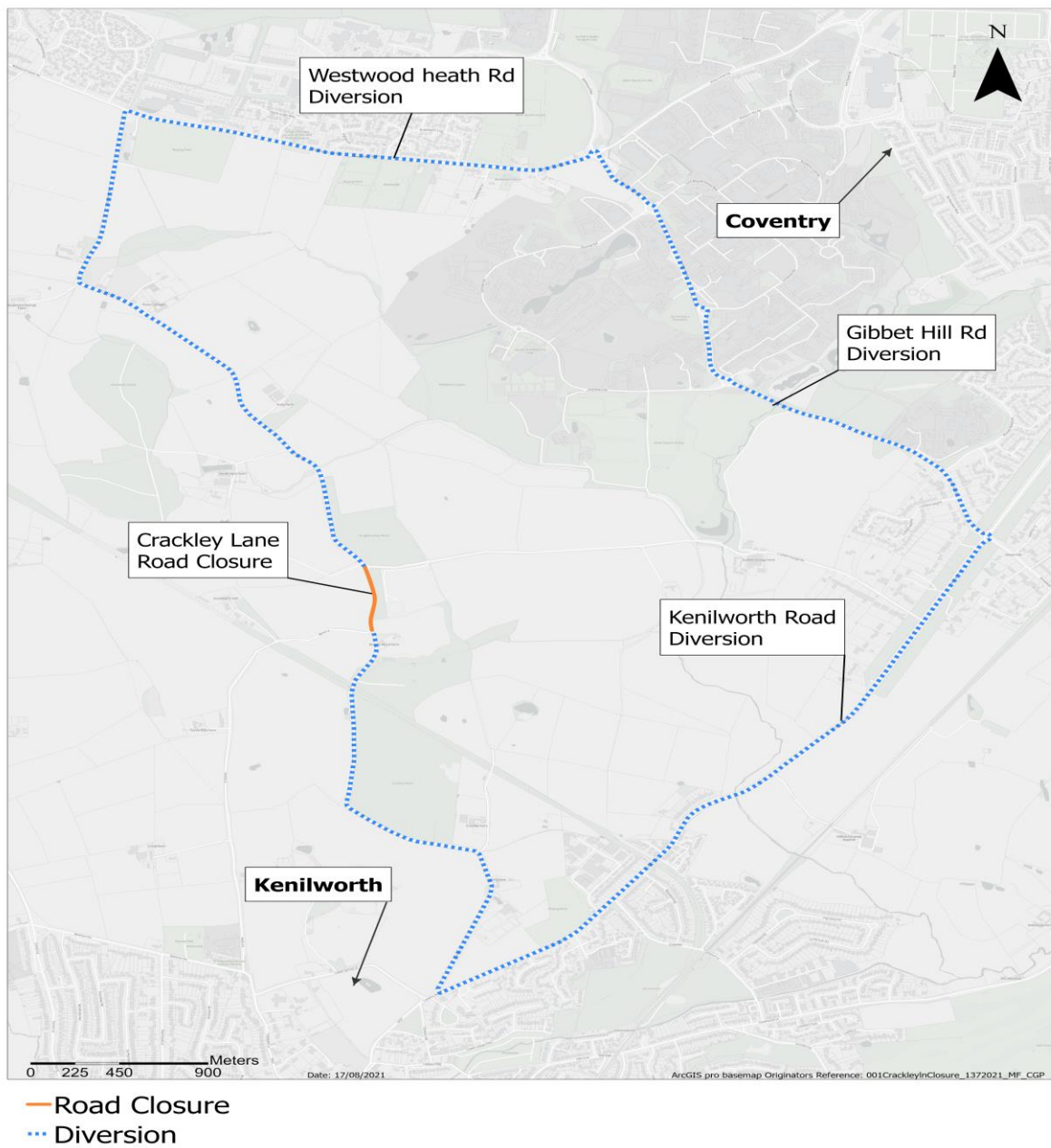
