# **North Gower Street Junction with Drummond Street** Reinstatement - 18 October 2021

On Monday 18th October CSJV will be carrying out reinstatement works to replace the current road surface. The works will take place in North Gower Street close to the junction of Drummond Street for a period of 1 day. Works will also be taking place in the footpath to replace concrete around a Vodafone chamber. A temporary directional lane closure will be in place while these works are carried out. Drummond Street will remain open to vehicles and pedestrians.

# **Euston Street junction with Cobourg Street – 18** October 2021

On Monday 18th October CSJV will be carrying out reinstatement works to replace the current road surface, the works will take place in Euston Street close to the junction of Cobourg Street for a period of 1 day. Temporary signage, lighting and barriers will be in place throughout the works.

# **Drummond Street junction with Cobourg Street -Monday 18 October**

On Wednesday 18<sup>th</sup> October CSJV will be carrying out reinstatement works to replace the current road surface. The works will take place in Drummond Street close to the junction with Cobourg Street for a period of 1 day. A temporary directional lane closure will be in place while these works are carried out. Drummond Street will remain open.

# **Euston Street - Monday 18th October to Tuesday 19th October 2021**

From Monday 18<sup>th</sup> October to Tuesday 19<sup>th</sup> October, CSjv will be carrying out the installation of safety chains within the manhole on Euston Street, this work is expected to last for 2 days. While these works are taking place a full road closure of Euston Street will be required with a diversion route of Drummond Street and Cobourg Street


# Gower Street Slip Lane - Tuesday 19<sup>th</sup> October to Wednesday 20<sup>th</sup> October

From Tuesday 19<sup>th</sup> October to Wednesday 20<sup>th</sup> October, CSjv will be carrying out Anti-Skid resurfacing works on the Gower Street Slip Lane with Euston Road. A lane closure on the slip will be required for the duration of 2 days while these works are carried out.

# Gordon Street - Monday 18<sup>th</sup> October to Tuesday 19<sup>th</sup> October

From Monday 18<sup>th</sup> October to Tuesday 19<sup>th</sup> October, CSjv will be carrying out Anti-Skid resurfacing works on Gordon Street. The works will begin in the southbound lane, once complete the work site will be moved to the northbound lane. During these works a lane closure will be required.
