Completion of pipeline diversion works near Rookery Lane, Hints

High Speed Two (HS2) is the new high speed railway for Britain. To allow for the construction of the new railway and to continue to ensure a safe and reliable gas supply, Cadent has been working to move underground gas pipeline that runs near Rookery Lane, west of Hints, since April 2021.

What are we doing?

We have now finished moving the pipe on land either side of Rookery Lane, and have successfully carried out routine testing on the relocated pipeline. We have carried out work to replace topsoil and vegetation that we had to remove to carry out the diversion.

All Cadent work at this site is now complete.

We would like to thank local people for their continued patience throughout the duration of our work.

How will this affect you?

Cadent has left behind some equipment, including fencing, for other HS2 contractors working in the area to use.

The access that Cadent constructed off Rock Hill/Watling Street will also remain in place for other HS2 works. HS2 will keep people up to date as other works in the area progress.

COVID-19

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current COVID-19 strategy makes clear that construction activity can continue as long as it complies with this guidance. The health and safety of our workforce and the communities we affect is our key priority. What we will do


