Electrical Supply works on Old Oak Common Lane

We previously notified the community about ground investigation works taking place on Old Oak Common Lane. Once the ground investigation works are complete Scottish and Southern Electric Networks (SSEN) will be installing a new electric supply to their Substation within Crossrail Land, adjacent to the Old Oak Common Station site. This work is separate to the construction of Old Oak Common Station and the programme of HS2 works in the local

In order to carry out this work, SSEN will be installing traffic management on Old Oak Common Lane over the weekend on Saturday 16 and Sunday 17 October 2021. The works will involve excavating a trench in the road, laying a cable and making an electrical connection. At the end of the works SSEN will remove their traffic management and the road surface will be reinstated. This work has been coordinated with the existing traffic management further south on Old Oak Common Lane, and other HS2 works in the area to ensure disruption to traffic is minimal.
