Notice of utility surveys near Blenheim Crescent

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19.

What we are doing

We wrote you in April to advise you that we would be carrying out sewer investigations near Blenheim Crescent. We need to re-visit this location to carry out additional works that will take place on 15 November 2021.

The location of these works is shown on the map overleaf.

We will investigate the condition of the sewer system using a CCTV camera mounted on a small robot. Should we find a blockage, we may need to flush the drainage system using a high-pressure water jet in order to carry out the investigation.

To ensure the safety of operatives and rail users, these works will take place at night when trains are not running.

How the surveys might affect you

You may see people working along the railway tracks.

Your utility services will not be affected.

15 November 2021 between 8pm and 6am

We may be on site for an hour before the start and end of the shift

What to expect

Operatives and surveying equipment (including a CCTV camera) will be present, as well as a water tanker should we need to clear a blockage
