Notice of ground investigations on Eton Road

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. You can sign up for regular updates in your local area at www.hs2.org.uk.

We wrote to you recently about works to carry out utility surveys on Eton Road for one night on 1 December.

Works planned on Eton Road from 8 December

As part of our ongoing works to set up the Adelaide Road site, we will be carrying out ground investigation works on Eton Road. This will involve digging a temporary trench to confirm the location of utility services under the road surface. The ground investigation works will take approximately 10 days, starting from 8 December until 17 December.

We will be working during our core hours which are 8am to 6pm Monday to Friday and 8am to 1pm on Saturdays. Eton Road will be closed for the duration of these works, please see further information below.

How the trial holes might affect you

During the ground investigation works, a road closure will be in place on Eton Road to protect staff and ensure that traffic can safely move through this area. Parking bay suspensions will be in place.

The location of these works shown on a map on the following page and a clearly signed diversion route will be in place. This temporary change has been agreed with Camden Council in order to help maintain traffic flow on Adelaide Road and local streets.

Your utility services will not be affected.

8am to 6pm, Monday to Friday and 8am to 1pm Saturdays, if required

We may be on site for an hour before the start and/or end of each shift

Temporary traffic management and parking bay suspensions will be in place

What we will do

We will carry out ground investigations and surveys in your local area – measures will be in place to reduce disruption to residents, where possible

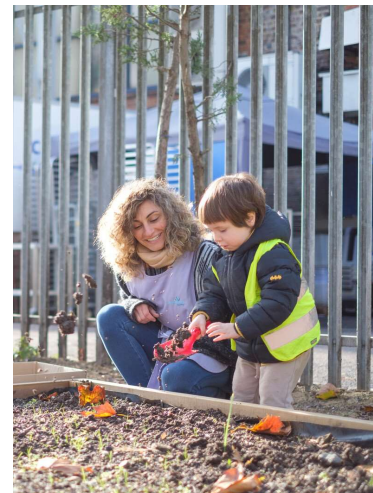
About our Community and Business Funds
