High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. You can sign up for regular updates in your local area at www.hs2.org.uk.

Surveys planned between 6 and 10 December

From 6 to 10 December 2021, we will be carrying out drainage surveys on Alperton Lane. The surveys are planned to take place during the day from 8am to 6pm. We will use a camera to investigate the condition of the drainage system and may need to flush the drains using a high-pressure water jet.

How might this affect you

Between 6 and 10 December, temporary lane closures will be in place during the day on Alperton Lane and May Gardens. Parking bay suspensions will be in place.

The map on the following page will show the location of the surveys.

Your utility services will not be affected during the surveys, and you will still be able to travel through this area. The dates and locations for the surveys could change and we may need to carry out further surveys in your area. To sign up for updates, please visit hs2.org.uk/in-your-area/

Parking bay suspensions will be in place on Alperton Lane and May Gardens

A water tanker will be present during the surveys should we need to flush the system

The date for these surveys may change - we will provide updates at hs2.org.uk/in-your-area/


