High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19.

What we are doing

From 23 to 25 November 2021, we will be clearing brambles in order to undertake surveys of the sewer at Blenheim Crescent. It is located near the Children's playground, in the area shown on the map overleaf.

We will be using strimmers to remove the vegetation and a CCTV camera mounted on a small robot to investigate the condition of the sewer. Should we find a blockage, we may need to flush the sewer system using a high-pressure water jet in order to carry out the investigation.

Access to the Blenheim Crescent Children's Playground will be maintained.

Your utility services will not be affected.

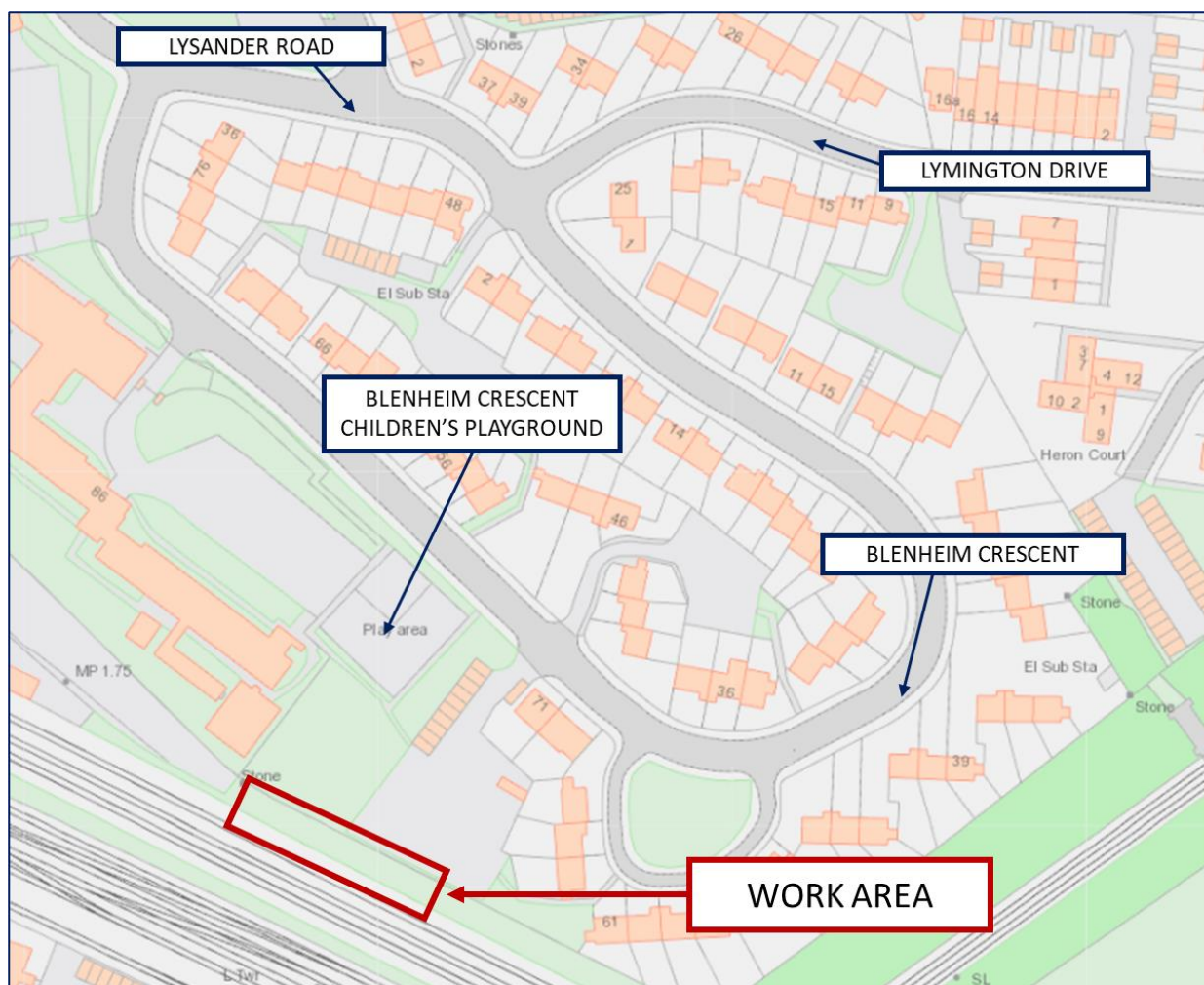
