





Notice of works at the Former **Maria Fidelis School**

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) guidance on COVID-19. The Government's strategy makes it clear construction can continue as long as it complies with this guidance. All sites remain under constant review. Piling works at the former Maria Fidelis site commencing late November 2021

We wrote to you in September 2021 to provide an update on the works at the former Maria Fidelis Catholic School (HS2-MW-MD-Ph1-Eu-St-S3-UT-22-09/02/2021). As part of the enabling works, we will create foundations in the playground area using a piling rig with a rotary bore which will make a hole in the ground and the hole will be filled with concrete. Piling works will begin late November 2021 and is expected to continue until late January 2022. Site works will be paused over the Christmas/ New Year period. Site will close from 23 December 2021 and open on 4 January 2022.

Duration of works:

From late November 2021 until late January 2021

Working hours:

- 8am to 6pm weekdays, bank holidays (with an hour either side of these times to set up and close down the site)
- 8am to 1pm Saturday

What to expect:

Drilling causing noise

What we will do:

- Use an auger cleaning tool. The use of this aims to reduce noise related to the removal of the excess material from the drilling rig
- All worksites will utilise 2.4m high perimeter hoarding to provide screening.

What to expect

We recognise that construction work can be disruptive to those living or working nearby. The nature of our work often means some disturbance is unavoidable, but please be assured that every effort is made to minimise any unnecessary noise. Please note that changes to the programme may occur and if these changes are likely to cause any disturbance, we will write to you again.

Works will include:

- Use of a rotary auger rig for piling. This will be supported by concreting operation;
- Use of an excavator (digger)
- Use of a vibratory roller;
- Use of a whacker plater; and
- We will work to minimise disruption wherever possible.

Working hours

- 8am to 6pm weekdays (excluding bank holidays);
- 8am to 1pm Saturdays; and
- We will set up and close down activities up to one hour before and after normal working hours shown here.
