# Notice of Public Right of Way Closures, Radbourne, Southam

High Speed Two (HS2) is the new high speed railway for Britain. We continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. # What are we doing?

We have begun excavating and moving earth with large items of construction plant and these works will soon cross the network of footpaths near Radbourne Lane, near Ladbroke village, referred to as footpaths SM96/1 SM96/2 and SM96a1.

Due to the location of these Public Rights of Way, and how they cross our construction area, a safe diversion route for walkers is currently not possible. The footpaths will be closed for period of approximately 3 years.

In early 2022, as our construction work progresses, we will assess if any alternative routes are possible.

Once our construction work is completed, these footpaths will be redirected under the Lower Radbourne Viaduct.

## When will these works take place?

Footpaths SM96/1 SM96/2 and SM96a1 will be closed on Monday 29 November. Closure notices will be signposted. These Public Rights of Way are expected to be closed for three years.

Install and maintain local signs to inform people of temporary closures and diversions.


