



Notice of Public Right of Way closures, Radstone

High Speed Two (HS2) is the new high speed railway for Britain. We continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. What are we doing?

As part of our preparatory works and for the safety of the public, we will be closing some Public Rights of Way (PRoW), including both footpaths and bridleways in the area of Radstone.

These closures are required to support the construction of our internal site access road as well as our bulk earthworks and excavations. Where possible, we will only close a section of a PRoW or bridleway.

Due to safety reasons as well as the programme of works, the PRoW's will be closed in two phases. The first phase of closures will be from November to December 2021. The PRoW's will then be reopened until the second phase of the construction and excavation in early 2022. We will look at ways to divert the PRoW's long term where possible.

When will these works take place?

Phase One is now complete and we now move into Phase Two of the works.

Phase Two

Works will commence Monday 10 January 2022 with a closure in place until January 2025.

Closure of AX15, AX14 and AX16 from January 2022 until January 2025.

We will provide an update during the works when we are able to reopen the PRoW or bridleway where possible.

Duration of works

Closures will commence Monday 10 January 2022

What to expect

Varied activities with both quiet and busier periods.

Footpath closures.

Noise from plant and equipment used for the works.

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.

Take care to respect the community.

Install and maintain local signs to inform people of temporary closures and diversions.

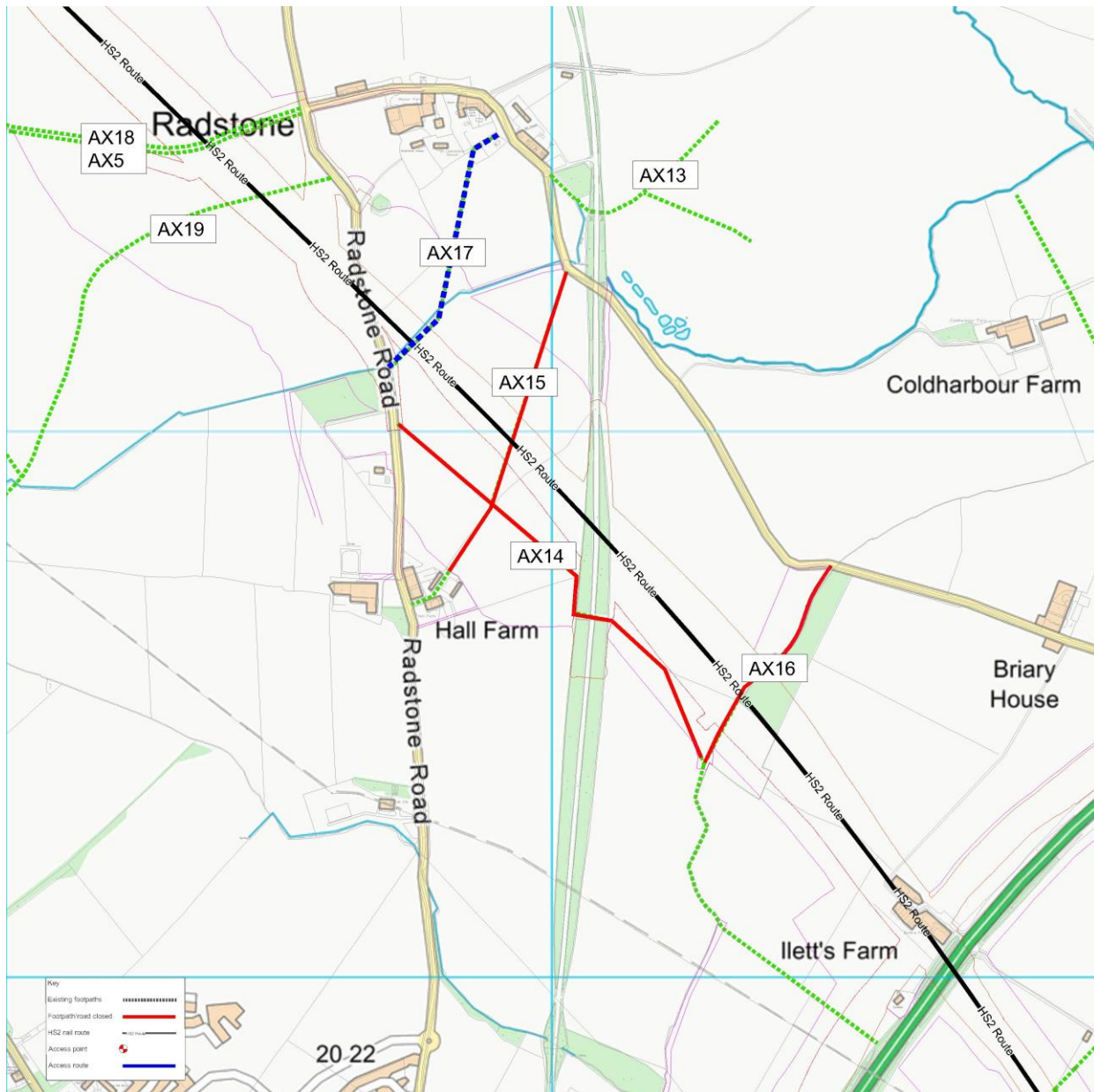

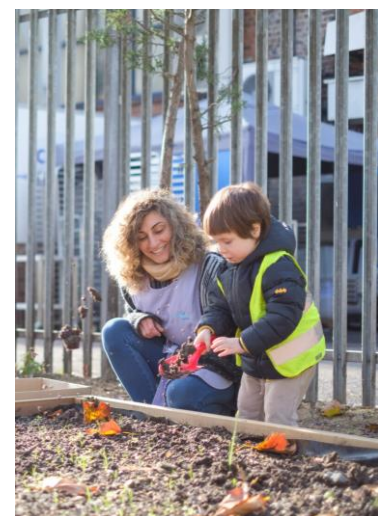
About our Community and Business Funds
