High Speed Two (HS2) is the new high speed railway for Britain. We continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. All sites will remain under constant review. You can sign up for regular updates in your local area at www.hs2inbucksandbox.co.uk.

What are we doing?

As part of utilities diversion works, low level de-vegetation works will take place on a section of Fiddlers/Snakes Lane.

In order to allow the works to take place, it is necessary to remove vegetation to enable future works to continue and to allow access to areas of the lane. Once the works are complete the lane will be open as normal.

When will these works take place?

A section of Fiddlers/Snakes Lane will be closed, during working hours, from Thursday 16th December to Friday 17th December, with a diversion in place.

We will work to reopen the lane as soon as possible.

Road closure and some additional traffic.

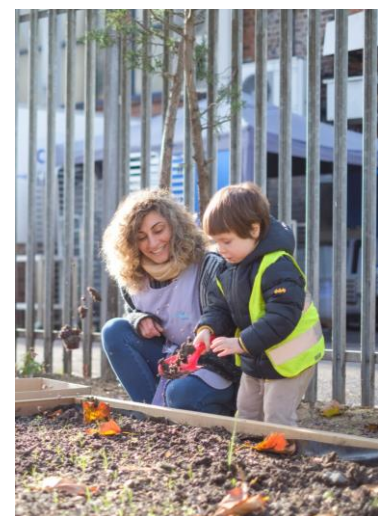
About our Community and Business Funds
