

# Update: Notification of upcoming road closure Rugby Road, Cubbington.

High Speed Two (HS2) is the high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

## Update

Due to a design change for these works, we now need to extend the working period from January 10 to 28 January 2022 instead of the planned end date of 17 January. Please accept our apologies for the delay and we will endeavour to complete these works quickly as possible

## The work we will be doing

We will be creating a plant crossing on Rugby Road, Cubbington. This crossing will allow us to safely move our construction plant across the road as we undertake various earthworks in the area.

In order to create the plant crossing, we will be closing Rugby Road to carry out the works in a safe and secure manner. The road will be closed for 24-hours, seven days including weekends while the works are being carried out. Please note that access will be maintained to frontages and businesses on Rugby Road while the works take place.

On completion of the plant crossing, the lights will remain green and will only turn to red when site vehicles are required to cross the road. To further reduce disruption, these lights will be manned during busier periods of the day. Please note that these works are subject to weather conditions.

## When these works will take place

We will be carrying out these works in two stages.

**Stage one** will be from **6 December to 17 December 2021**.

We will reopen the road after the 17 December for the Christmas and New year period. **Stage two** will be from **10 January to 28 January 2022** to complete the remaining works. The plant crossing will become operational from **31 January 2022** for the duration of the construction program and will operate during permitted working hours.

### Duration of works

#### Rugby Road

- Works are scheduled from 6 December to 17 December 2021 and then from 10 January 2022 to 28 January 2022.
- The road will be closed for 24-hours, seven days a week including weekends while the works are being carried out.
- Access to frontages on Rugby Road will be maintained during these works.

### What to expect

- Some disruption to travel times.
- Some noise from onsite machinery during working hours.
- Low levels of noise from the work we are completing.

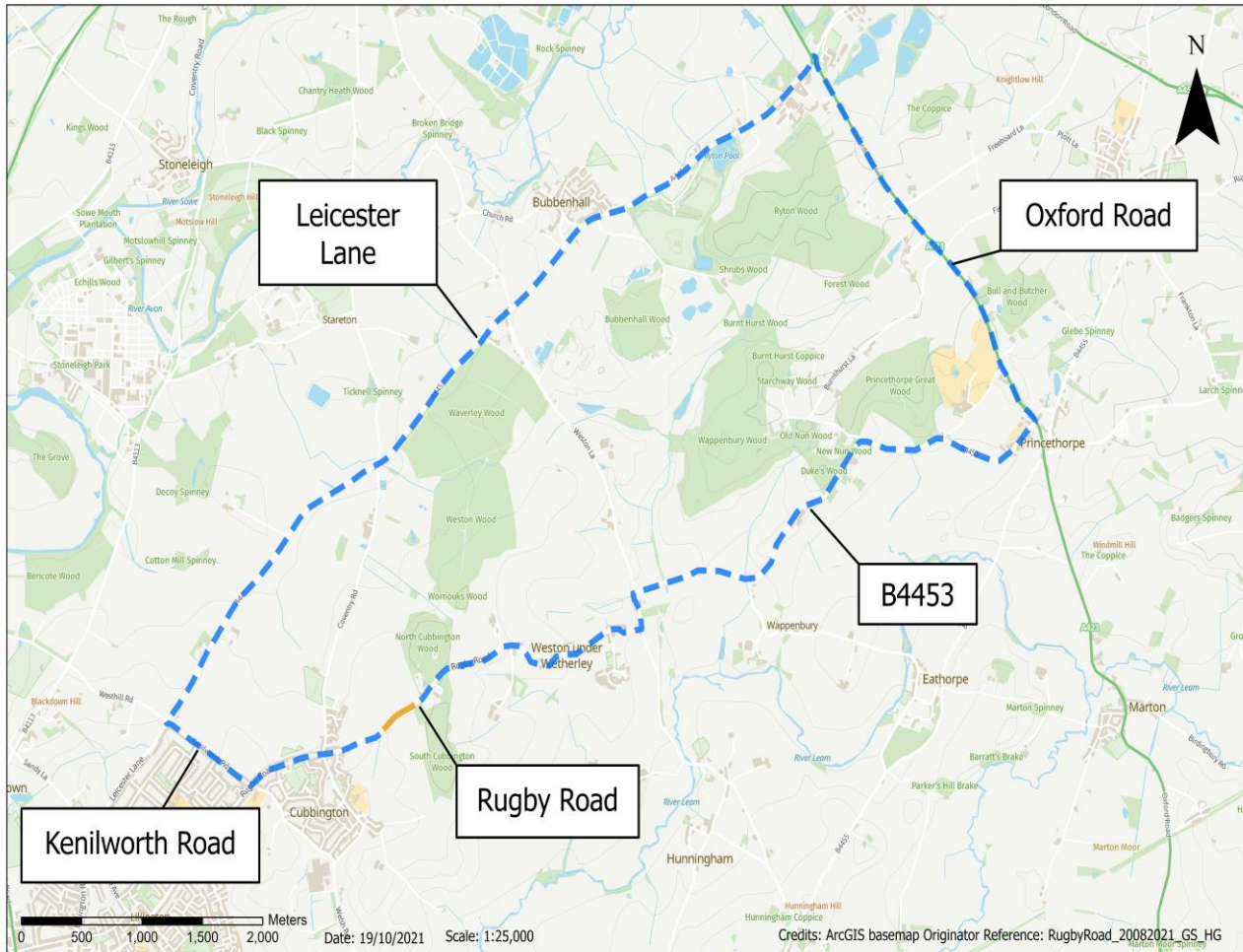
